Thrasher said that it would not be a problem reconnecting with them.

Council Member Dorst-Porada said that this would be useful data for the planning of the new community garden.

# Ontario Little Free Libraries (Shawn Thrasher)

Shawn Thrasher, Library Director, narrated a PowerPoint presentation on the update of the creation and installation of small, free libraries.

Board Member Mena asked where the books will come from and Thrasher answered that they will come from The Friends of the Library but also from the "Take a Book, Leave a Book" idea. Library, Recreation and Museum staff will watch over these boxes and if they look empty, they will notify the Friends of the Library to fill them. City Council Member Dorst-Porada reiterated that this does not mean people can't donate books and Thrasher answered that the library always wants donated books.
