## ONTARIO CITY COUNCIL/ HOUSING AUTHORITY MINUTES April 4, 2017

#### JOINT MEETINGS

Regular meetings of the Ontario City Council/Ontario Housing Authority were held on Tuesday, April 4, 2017 at the Ontario City Hall, 303 East B Street, Ontario, California.

#### CALL TO ORDER - OPEN SESSION

Mayor pro Tem Dorst-Porada called the City Council/Housing Authority meetings to order at 6:30 p.m., and requested the City Clerk call the roll.

Also present were City Manager/Executive Director Al C. Boling, City Attorney/Legal Counsel John Brown and City Clerk/Secretary Sheila Mautz.

The Pledge of Allegiance was led by Council Member Bowman.

In the absence of the Pastor, Mayor pro Tem Dorst-Porada requested a moment of silence.

#### PUBLIC COMMENTS

Ray Gonzales a Neighborhood Watch Representative spoke about the positive relationship they have with the City. He requested the City's assistance in addressing parked on the following streets: Inverness Court, Carnoustie Court, Merion Drive, and La Costa Court. He mentioned the parked vehicles have impacted street sweeping, trash pickup, school bus drop off, and caused a lack of guest parking for residents.

Mayor pro Tem Dorst-Porada asked City Manager Boling to assist him.

John Egan spoke about OMSD's Measure K and how it was not supposed to be used to fund development of school gyms, rather it was for the replacement of things like the lead piping that currently delivers brown water to the drinking fountains at the schools. He mentioned a flier that stated Measure K would pay for the update of classrooms, restrooms, roofs, replacement of air-conditioning systems, removal of asbestos, and lead paint at schools. He stated that the verbiage used for Measure K was misleading and he was upset that the School Board Members were using Measure K funds to pay for their individual pet projects rather than infrastructure changes needed to keep the students safe. He asked about the Ontario-Montclair School District Board Members fiscal

responsibilities. He invited the public who were passionate about the issue to join him during the Ontario-Montclair School District Board meeting on Thursday, April 6, 2017 at 7:00 p.m.

Moe Mendoza spoke about a code enforcement complaint. She stated that the apartment she resides in had been cited for multiple code violations including the illegal construction of a garage. She commented regarding the recommended removal of the garage that has been in place for at least 10 years, and asked how Code Enforcement officer allowed so much time to pass before realizing it was constructed illegally. She asked that only a supervising code enforcement officer review the property to prevent further confusion in the future.

**MOTION UNANIMOUSLY CARRIED.** Mayor pro Tem Dorst-Proada declared City Council Resolution Nos. 2017-018, 2017-019, 2017-020, 2017-021, 2017-022, 2017-023, and Ordinance No. 3071 unanimously adopted by those present, with Mayor Leon and Council Member Wapner absent.

#### STAFF MATTERS

City Manager Boling spoke about National Dispatch Appreciation Week April 9-15 and acknowledged all dispatchers serving the City. He also spoke about a nationwide challenge amongst cities called the Mayor's Water Challenge. The goal is to see how many residents pledge to do their part to conserve water. He stated if Council was willing to make the challenge again, more of the community would make the pledge.

Mayor pro Tem Dorst-Porada stated that they were making the challenge and noted that last year's pledge saved nearly a million gallons of water. She spoke about the national exposure the City receives by doing the right thing, and that residents of the winning City will be eligible for a drawing to win nearly \$50,000 in eco-friendly prizes, including a Toyota Prius as the grand prize. #### COUNCIL MATTERS

Council Member Bowman has no comments.

Council Member Valencia commended the Ontario Police Department who participated in the Baker to Vegas Run. The team placed 25 out of 274 teams who competed and completed the relay race in 15 hours and 29 minutes, just eleven minutes shy of beating Fontana who came in at 15 hours and 18 minutes. He challenged the Chief to beat Fontana's time next year.

Mayor pro Tem Dorst-Porada brought Jasper the Ant, noting her effort to make him the City's mascot. She also thanked the staff who organized the State of the City event and acknowledged their hard work.
