#### JOINT MEETINGS

#### **CLOSED SESSION**

Mayor Leon called the City Council and Housing Authority Meetings to order at 6:04 p.m., with all members present.

City Council considered and adopted a resolution to authorize the execution of a First Amendment to Acquisition and Funding Agreement between the City and STG Communities II, LLC to provide for the acquisition of completed public facilities constructed by STG Communities II, LLC with the proceeds of Community Facilities District No. 42 (CFD No. 42 – West Haven) special tax bonds.

- (D) Directed City staff to file a Notice of Exemption based upon the City Council's finding that the impacts for this agreement is not a project and subject to environmental review and that there is no possibility that the activity in question may have a significant effect on the environment.

City Council considered and adopted resolutions approving and authorizing the City Manager to enter into Historic Preservation Agreements (Mills Act contract) for the following properties:

- File No. PHP19-004, 205 East Sixth Street (APN: 1047-241-03), Darius Long
- File No. PHP19-007, 408 West Armsley Square (APN: 1047-341-09), Jason and Maria Lawliss
- File No. PHP19-008, 130 East J Street (APN: 1048-071-05), Peter Bugbee
- File No. PHP19-010, 907 North Euclid Avenue (APN: 1048-043-13), John Aylyng and Dianne Fife

Notice of public hearing was duly given and affidavits of compliance are on file in the Records Management Department.

There were no written communications.

Executive Director of Development Murphy provided an overview of the proposed properties as follow:

The Robert N. Williams House, 205 East Sixth Street, is Local Landmark No. 82, with improvement value of \$57,350, potential savings of \$19,950 and reduction in City Revenue over 10 years of \$3,350.

The Stephen A. Craig House, 408 West Armsley Square, in the Armsley Square Historic District, with improvement value of \$78,497, potential savings of \$30,060 and reduction in City revenue over 10 years of \$5,050.

The C.E. Pratt House, 130 East J Street, in the Rosewood Court Historic District, with improvement value of \$53,400, potential savings of \$29,800 and reduction in City revenue over 10 years of \$5,006.

The Captain John P. Robertson House, 907 North Euclid Avenue, Local Landmark No. 40. With improvement value of \$141,200, potential savings of \$20,870 and reduction in City revenue over 10 years of \$3,506.

He indicated that this will bring the total Mills Act contracts to 77, at an estimated 10-year total cost to the City of \$230,560 for an estimated \$3,162,975 in investments and improvements.

Mayor Leon opened the public hearing asking those persons interested in this item to speak. Hearing no one, Mayor Leon closed the public hearing.

Council Member Wapner inquired about the reported property owners' tax savings and whether they represented only the City's portion, and not the County and State portion. Staff confirmed. He further questioned the age requirement of properties

to qualify for the Mills Act. Staff indicated that the property would generally need to be at least 50 years old and also subject to specific criteria.

**MOTION:** Moved by Council Member Dorst-Porada, seconded by Mayor pro Tem Valencia and carried by a vote to 4 to 0 with Council Member Bowman abstaining to adopt Resolution Nos. 2019-166 through 2019-169.

#### **COUNCIL MATTERS**

Mayor pro Tem Valencia reminded everyone to exercise safety during the holiday season and noted he observed people shopping at the Ontario Mills mall and leaving their purchases in plain view in the back seats of their cars. He stressed that there are opportunists who will take advantage of that situation and encouraged everyone to not be a victim.

Council Member Bowman invited everyone to participate in the annual Stuff a Bus Toy Drive to be held at Mathis Bros. Furniture on Friday, December 6, 2019 from 4:00 a.m. to 6:00 p.m. He also congratulated staff for overseeing a beautiful project on Euclid Avenue which included installation of a recycled water line with a street overlay afterward.

Council Member Dorst-Porada reminded the community of the annual 5k Reindeer Run, Christmas on Euclid Experience, and the Kiwanis Pancake Breakfast all to be held on December 14, 2019 in downtown.

Council Member Bowman commented on the incoming rains and inquired where residents could obtain sandbags. City Manager Ochoa responded that sandbags were available at all fire stations and sand was available at any of three designated parks: John Galvin Park, De Anza Park and Anthony Munoz Park.

Mayor Leon noted that Niagara Water is a local business that assisted the City in rehabilitating Creekside Park a few years ago. He further noted that after some vandalism to park equipment, Niagara paid approximately \$35,000 for new, replacement playground equipment for kids in the area.
