CALL TO ORDER - OPEN SESSION

Mayor Leon called the City Council and Housing Authority meetings to order at 6:36 p.m.

REPORT ON CLOSED SESSION

City Attorney Huber advised that there were no reportable actions from the Closed Session discussions.

The Pledge of Allegiance was led by Council Member Valencia.

Mayor Leon led a moment of silent reflection in lieu of the Invocation.

PUBLIC COMMENTS

Assistant City Clerk Kasad reported that there were three pieces of e-mailed correspondence which had been provided to the City Council from:

Daniela Bellissimo Ed Hambly III Sara Carrillo

and one telephonic public comment which was played for the Council as follows:

Rocio Renderos, resident of Miramonte Avenue, expressed concern with large truck traffic on this very small street. She noted that with people working at home, the traffic has become particularly disruptive. Mayor Leon concurred that this was a small street. City Manager Ochoa indicated that staff was looking into the matter.

Supervisor Hagman addressed the City Council via teleconference and detailed the Board of Supervisors' efforts to gain local control from the State over criteria with regard to COVID-19 restrictions and the ability for businesses to reopen. He indicated that many places are now open with curbside retail pick-up, non-urgent medical care and restaurants should be opening by the end of the month. He stressed the County's efforts to work with the cities as partners to establish testing sites. He noted the County's efforts to move underutilized City employees to the County to assist with contact tracing, rather than hire new County employees. Mayor Leon inquired about pending legislation to which Supervisor Hagman indicated that there was a federal bill pending to provide as much reimbursement as possible and would hopefully be in place by mid-June. Mayor Leon thanked Supervisor Hagman for the update to the community.

City Council awarded Bid No. 1182 and authorized the purchase of Palo Alto network security firewalls in the amount of \$99,430 for the Ontario Police Department network from FortNetSecurity, Inc. (FSI) of Gilroy, California.

City Council authorized the City Manager to execute an amendment to the agreement with Collaborative Solutions, LLC, of Reston, Virginia, for Workday on-demand support extending the term by three years and increasing the revised authorized contract amount by \$300,000, for a new total of \$400,000.

City Council considered and adopted a Resolution of Necessity for the purposes of acquiring permanent road right-of-way and temporary construction easement (TCE) interests in a portion of real property located at 9131 East Merrill Avenue, by eminent domain, for the widening of Merrill Avenue, east of Carpenter Avenue.

Notice of public hearing was duly given and affidavits of compliance are on file in the Records Management Department.

There were no written communications.

City Manager Ochoa explained that this was a required procedural step for the initiation of an eminent domain action. He explained the required steps regarding public interest and necessity and requirements for greatest public good over least private injury. He presented a photo of the project area and detailed the required right-of-way acquisitions. He noted that a portion of the affected site was going to be used for a temporary construction easement and would be returned to the property owner once the project is complete.

City Council read by title only, waived further reading, and adopted an urgency ordinance repealing City of Ontario Ordinance No. 3159 and enacting amendments to the City's existing regulations on the eviction of residential tenants, commercial tenants, and storage unit patrons experiencing a loss of income due to the COVID-19 pandemic, to make technical corrections and to include regulations on foreclosures.

There were no written communications.

Mayor Leon opened the public hearing asking those persons interested in this item to speak. The City Clerk reported no comments and Mayor Leon closed the public hearing.

MOTION: Moved by Council Member Bowman, seconded by Council Member Wapner and carried by unanimous roll call vote to introduce and waive further reading of Ordinance No. 3163.

ORDINANCE NO. 3163 AN URGENCY ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, REPEALING URGENCY ORDINANCE NO. 3159, ADOPTING TEMPORARY REGULATIONS PROHIBITING THE EVICTION OF RESIDENTIAL TENANTS, COMMERCIAL TENANTS, AND STORAGE UNIT PATRONS, AND ENACTING A MORATORIUM ON RESIDENTIAL FORECLOSURES DUE TO LOSS OF INCOME DURING THE STATE OF LOCAL EMERGENCY CAUSED BY THE COVID-19 PANDEMIC.

ADMINISTRATIVE REPORTS/DISCUSSION/ACTION

21. RECEIPT AND FILING OF INFORMATION RELATED TO THE CITY'S INTENTION TO PROVIDE TWO-YEARS ADDITIONAL SERVICE CREDIT IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 20903

City Council, by motion, received and directed the filing of information related to the City's intention to provide two-years additional service credit in accordance with California Government Code section 20903 for designated classifications, departments, or organizational units.

City Manager Ochoa explained the significant impacts caused by the COVID-19 pandemic on the City's revenues and activities and staff's efforts to reorganize and restructure. He indicated that part of that action plan was the use of a benefit under the CalPERS system for an early retirement option with two years of additional service credit. He indicated that there were currently 320 eligible employees with a potential maximum annual savings of \$51 million if everyone took advantage. He requested that the City Council receive and file the report and advised that staff would return at a future City Council meeting with a better estimate based upon those interested in the option. He stressed the importance of still maintaining service levels for the public.

Council Member Wapner thanked City Manager Ochoa and City staff for their quick and appropriate action in providing this recovery plan. He stressed the massive loss of revenue and concurred that this was a fair way to balance the budget.

Council Member Bowman concurred that this showed good leadership and was a good move.

Mayor pro Tem Dorst-Porada noted that she was on a call with the League of California Cities regarding the pandemic's economic impact, and because of Ontario's revenue sources, it has been hit hard compared to other cities. She expressed hope that retail will bounce back better than forecasted. She also indicated that the plan presented by staff providing options for Council's consideration was very well done, and she thanked City Manager Ochoa. Mayor Leon also thanked City Manager Ochoa on a good job.

MOTION: Moved by Mayor pro Tem Dorst-Porada, seconded by Council Member Bowman and carried by unanimous roll call vote to receive and file this report.

STAFF MATTERS

City Manager Ochoa noted for Council and community awareness the availability of COVID testing opportunities and indicated that the County had expressed interest in using a property owned by the City as soon as next week to provide the community with tests. He stated that the County would liable for and have responsibility to sanitize the facility.

COUNCIL MATTERS

Mayor pro Tem Dorst-Porada commented that City Hall staff is still working hard. The library is now making books available for pick-up, doing video programs and a summer reading program all on-line. The Museum is doing Zoom meetings with the Board and staff. She noted that the September Art Festival had to be postponed, but they are working to make the event even better when it returns next year. She indicated that the Chaffey Community Museum of Art is working with two professors who are writing a book tied to their collection which will be presented as a joint event.

Council Member Wapner commented on activity at the airport, noting that it has been hit hard by the COVID pandemic. He advised that the passenger count is down over 95%; however, there is an increase in cargo levels of 20%, driven by e-commerce demands. He noted that it will be a slow process to bring activity levels back up.

Council Member Bowman had no comments.

Council Member Valencia commended staff for going above and beyond during this critical time. He addressed teachers and noted that they are having to cope with students graduating and not being able to participate in the graduations. He indicated that the community was trying to come together and thanked the teachers for making the best of a bad situation.

Mayor Leon echoed the concerns about kids not being able to celebrate graduations. He expressed hopes that something could be done to make it up to them in the future. He noted a recent drive-by celebration for Chaffey High School drama teacher Dave Masterson on his retirement and cancer recovery. Mayor Leon also reiterated the efforts in conjunction with Supervisor Hagman to get local control and start reopening businesses as well as obtaining federal funding. He noted that bad situations bring out the best in people and commented Integrated Waste employee Bruce Johnson who stopped his truck to sing to some graduating students. The video has since gone viral on social media. He thanked Mr. Johnson for being a good representative of the City and noted that this reflects well on the entire City.
