City Council approved the Minutes for the regular meeting of the City Council and Housing Authority of April 17, 2018, as on file in the Records Management Department.

### 2. BILLS/PAYROLL

City Council approved **Bills** for the period March 25, 2018 through April 7, 2018, in the amount of \$6,668,935.27 and **Payroll** for the period March 25, 2018 through April 7, 2018, in the amount of \$3,313,135.46, when audited by the Finance Committee.

3. AN EXCLUSIVE NEGOTIATION AGREEMENT BETWEEN THE CITY OF ONTARIO AND BRAND PACIFIC CONSTRUCTION INCORPORATED (200 NORTH EUCLID AVENUE – FORMER BANK OF ITALY/BUMSTEAD BICYCLES BUILDINGS)

City Council approved an Exclusive Negotiation Agreement between the City of Ontario and Brand Pacific Construction Incorporated of Glendale, California, and authorized the City Manager to execute the Agreement and all other documents required for implementation of the Agreement.

## 4. A CONSTRUCTION CONTRACT FOR THE FRANCIS/TURNER STREET IMPROVEMENT PROJECT/LEE & STIRES, INCORPORATED

City Council approved the plans and specifications and awarded a construction contract to Lee & Stires, Incorporated of Ontario, California for the Francis/Turner Street Improvement Project (ST1309) in the bid amount of \$944,432 plus a 20% contingency of \$188,886, for a total authorized amount of \$1,133,318; and authorized the City Manager to execute said contract and related documents and file a Notice of Completion at the conclusion of the construction activities.

## 5. CONSTRUCTION CONTRACT FOR TRAFFIC SIGNAL MODIFICATIONS AT ARCHIBALD AVENUE AND MISSION BOULEVARD/INTERNATIONAL LINE BUILDERS, INC.

City Council approved the plans and specifications, and awarded a construction contract to International Line Builders, Inc. of Riverside, California, for the traffic signal modifications at Archibald Avenue and Mission Boulevard in the bid amount of \$228,046 plus a nine percent (9%) contingency of \$20,524 for a total authorized expenditure of \$248,570; and authorized the City Manager to execute said contract and related documents, and file a notice of completion at the conclusion of all construction activities.

# 6. A RESOLUTION APPROVING AN IMPROVEMENT AGREEMENT, IMPROVEMENT SECURITY AND FINAL TRACT MAP NO. 18068 LOCATED AT THE NORTHEAST CORNER OF PARKVIEW STREET AND CELEBRATION AVENUE

City Council adopted a resolution approving an improvement agreement, improvement security and Final Tract Map No. 18068 located at the northeast corner of Parkview Street and Celebration Avenue within the Subarea 29 Specific Plan area.

**RESOLUTION NO. 2018-038** A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, APPROVING AN IMPROVEMENT AGREEMENT, IMPROVEMENT SECURITY AND FINAL TRACT MAP NO. 18068, LOCATED AT THE NORTHEAST CORNER OF PARKVIEW STREET AND CELEBRATION AVENUE.

### 7. AUTHORIZE THE PURCHASE OF A FLEET VEHICLE - FIRE WATER TENDER/KME

City Council authorized the sole source purchase and delivery of one KME Tandem Axle Water Tender in the amount of \$571,650 from KME of Jurupa Valley, CA.

### 8. FISCAL YEAR 2017-18 THIRD QUARTER BUDGET UPDATE

City Council approved the budget adjustments and recommendations as listed in the Fiscal Year 2017-18 Third Quarter Budget Update Report.

## 9. A RESOLUTION OF INDUCEMENT TO ISSUE TAX-EXEMPT BONDS FOR ONTARIO TOWNHOUSES, LOCATED AT 1360 EAST D STREET

City Council approved a Resolution of Inducement to issue tax-exempt bonds for Ontario Townhouses, located at 1360 East D Street, Ontario.

City Council received and filed the Final 10-Day Report for Interim Urgency Ordinance No. 3056.

15. COST SHARING AGREEMENT WITH CHAFFEY JOINT UNION HIGH SCHOOL DISTRICT FOR SCHOOL RESOURCE OFFICERS

City Council approved and authorized the City Manager to execute a two-year cost sharing agreement with the Chaffey Joint Union High School District for three school resource officers in the amount of \$450,000.

16. AMENDMENT TO THE CITY OF ONTARIO LOCAL GUIDELINES FOR IMPLEMENTING THE CALIFORNIA ENVIRONMENTAL QUALITY ACT ("CEQA")

City Council adopted a resolution approving the 2018 amendment to the "City of Ontario Local Guidelines for Implementing the California Environmental Quality Act".

**MOTION UNANIMOUSLY CARRIED:** Mayor Leon declared City Council Resolution Nos. 2018-038, 2018-039, 2018-040, 2018-041, 2018-042, 2018-043 and 2018-044 unanimously adopted.

### **PUBLIC HEARINGS**

17. AN APPEAL OF THE PLANNING COMMISSION'S DECISION TO APPROVE A DEVELOPMENT PLAN (FILE NO. PDEV17-046) TO CONSTRUCT A 4,500 SQUARE-FOOT SELF-SERVICE CARWASH (FAST 5 XPRESS) IN CONJUNCTION WITH A CONDITIONAL USE PERMIT (FILE NO. PCUP17-021) TO ESTABLISH AND OPERATE THE DRIVE-THRU CARWASH, ON 0.93 ACRES OF LAND, WITHIN THE COMMERCIAL LAND USE DESIGNATION OF THE GROVE AVENUE SPECIFIC PLAN, LOCATED AT 2345 S. GROVE AVENUE. (APN: 0216-081-25)

Staff recommended that the City Council uphold the Planning Commission's approval of File Nos. PDEV17-046 and PCUP17-021, a Development Plan to construct a 4,500 square-foot self-service carwash in conjunction with a Conditional Use Permit to establish and operate the drive-thru carwash, within the Commercial land use designation of the Grove Avenue Specific Plan, located at 2345 S. Grove Avenue; and take further actions necessary and consistent with the City Council's final determination and decision on the matter.

Notice of public hearing was given and affidavits of compliance are on file in the Records Management Department.

There were no written communications.

Mayor Leon opened the public hearing asking those persons interested in this item to speak.

Tom Utman, Owner of Fast 5 Express, detailed his project and application process that began in September 2017. He noted that he had met with the adjacent mobile home park and shared his efforts to address the concerns of the appeallant.

Sylvia DeVries, Appellant, detailed her concerns with noise pollution, air polllution and the impact of this project on their overall quality of life, noting that most of the mobile home park residents are seniors with health issues. She stressed the continuous daily noise the project will generate from 6:45 a.m. to 8:00 p.m. and the volume of cars that will be washed.

David Walthall, presented a petition opposing the proposed project and stressed the age of the mobile homes in the park and noted that most have thin walls and single pane windows that will be particularly impacted by the car wash noise. He expressed concerns with overall noise and the petitioners' interests in minimizing the impacts on their daily lives.

Marlund Hale, Acoustical Engineer, indicated that he has spent 30 years fighting noise pollution. He advised that he has been hired by Fast 5 Express on several of their projects to address and abate noise concerns. He detailed his work to monitor noise at this location during various high volume times and advised that the results of his testing were presented in his reports; and neither exterior nor interior noise restrictions would be violated by this proposed project.

Hearing no additional requests to speak, Mayor Leon closed the public hearing.

City Attorney Egger clarified the City Council's role as the appellate body in the decision making process.

Mayor pro Tem Wapner thanked the residents for exercising their right to appeal. He commented that in spite of that he has heard, a clear message from the attorney that the Council cannot overturn the Planning Commission decision because the testimony and evidence supports the record and recommendation. He stressed that he could not support the appeal based on legal advice.

Council Member Dorst-Porada noted that the testing indicated that the noise would not exceed the noise restrictions, but questioned what the recourse would be if it did. City Manager Ochoa stated that if noise became a nuisance, it would fall under Code Enforcement protocols and they would stand ready to pursue bringing the business into compliance.

### **COUNCIL MATTERS**

Council Member Dorst-Porada had no comments.

Mayor pro Tem Wapner noted item number 15 of this agenda and explained that there are School Resource Officers at each high school in the City. He expressed appreciation for the partnership with Chaffey Joint Union High School District and stressed that everyone recognizes and is helping to address the potential dangers in our schools.

Council Member Bowman had no comments.

Council Member Valencia reported that on April 18, 2018, he and the City Manager attended the League of California Cities' Legislative Action Day in Sacramento, meeting with State Senator Leyva and Assemblyman Rodriguez to discuss local issues. Valencia also reported that during the week of April 30, 2018, he attended the National Police Activities League Conference in Florida where mental health issues, drugs and mentorship programs were discussed. Valencia recalled that about 15 years ago there was a boxing program in the community that promoted mentorship and offered kids an opportunity to get involved with community members who cared. He stressed the importance of this type of program to help prevent the kind of tragedies we see in the news. Council Member Valencia also noted that the City's summer concerts and movies in the park start May 30, 2018.

Mayor Leon announced that on May 30, 2018, his favorite band "Britain's Finest", a Beatles tribute band, would be performing at the first summer concert. Leon reported that there would be a series of concerts on Wednesdays throughout the summer, with local talent performing before each. He also commented on the movies scheduled each Friday night at Ontario Town Square. Mayor Leon talked about the downtown Cinco de Mayo event, coordinated by Unidos por la Musica, noting that it was an event for the entire community, with the money raised to benefit people in the City during the upcoming Christmas and Thanksgiving holidays.

### **ADJOURNMENT**

Mayor Leon adjourned the meetings of the Joint Agencies at 7:05 p.m. and announced the next regular meetings to be held on Tuesday, June 5, 2018.
