## JOINT MEETINGS

Regular meetings of the Ontario City Council/Ontario Housing Authority were held on Tuesday, December 5, 2017 at the Ontario City Hall, 303 East B Street, Ontario, California.

## **CALL TO ORDER - OPEN SESSION**

Mayor Leon called the City Council/Housing Authority meetings to order at 6:32 p.m., and requested the City Clerk call the roll.

The Pledge of Allegiance was led by Council Member Valencia.

Associate Pastor Jack Freeman, The Light of the World Church, provided the Invocation.

## **PUBLIC COMMENTS**

Johan & Omar Cuevas Ramirez, addressed the issue of street vendors and requested that the Council consider adopting an ordinance allowing them. The brothers spoke of their recent conversations with City Code Enforcement staff, and explained their understanding of the difficult issues that Code Enforcement deals with as well as the need to protect the public's health and safety. They want to help vendors be able to work and provide an income for their families.

Daisy Zamacona, Ramiro De La Torre, Giovanni Aguilar, Carla Valdavia, from De Anza Middle School, made a presentation on their school project which was to develop a proposed way to address the dangers to pedestrians while crossing Euclid Avenue near De Anza Park. Their project suggested the construction of a bridge over Euclid Avenue somewhere between Acacia Street and Budd Street to decrease the potential dangers.

Kevin Fugate, Ontario Professional Firefighters Association Local 1430, invited the City Council and the community to participate in the annual ABC 7 Toys for Tots, Stuff a Bus event on Friday, December 8 from 4:30 a.m. to 6:00 p.m. at the Mathis Brothers parking lot. He noted that the Ontario event has been so successful in receiving donated toys that they are able to provide some to other fire departments. The toys are then passed out to students at every school in the Ontario-Montclair School District.

City Manager Ochoa requested that the Council consider adjourning this meeting in memory of City employee Guy Admire, who died in an automobile accident on the way to work, Friday December 1. Guy, a Combination Building Inspector, was well-liked by those who worked with him in the Building Department as well as those who came in contact with him. He will be missed.

4. A COOPERATIVE AGREEMENT WITH THE SAN BERNARDINO COUNTY TRANSPORTATION AUTHORITY FOR THE SAN BERNARDINO VALLEY COORDINATED TRAFFIC SIGNAL SYSTEM OPERATION AND MAINTENANCE PROJECT

City Council approved a Cooperative Agreement between the City of Ontario and the San Bernardino County Transportation Authority (SBCTA) for the San Bernardino Valley Coordinated Traffic Signal System (SBVCTSS) Operation and Maintenance Project within the City of Ontario; and authorized the City Manager to execute said agreement and any future amendments within the City Council approved budget.

5. A RESOLUTION ORDERING THE SUMMARY VACATION OF AN EASEMENT FOR STORM DRAIN PURPOSES

City Council adopted a resolution ordering the summary vacation of an easement for storm drain purposes lying within Parcel 3 of Parcel Map No. 19612, generally located at the southwest corner of the intersection of Fourth Street and the Cucamonga Creek Channel within the Meredith International Specific Plan.

## City Council:

- (B) Authorized the City Manager to execute a three-year Public Works Contract for Contract No. SM1718-3 with C.J. Concrete Construction, Inc. located in Santa Fe Springs, California, for an annual estimated cost of \$175,000; and
- (C) Authorized the addition of future service areas and the option to extend the contracts for up to two one-year periods consistent with the City Council approved budgets.

City Council received public comment for the Fiscal Year 2017-18 Citizen's Option for Public Safety (COPS) / Enhancing Law Enforcement Activities Subaccount (ELEAS) Grant; and approved the proposed spending plan.

Notice of public hearing has been given and affidavits of compliance are on file in the Records Management Department.

Mayor Leon opened the public hearing asking those persons interested in this item to speak. Hearing no one, Mayor Leon closed the public hearing.

She also announced that the Noel Committee was inviting everyone to join them on December 16, 2017, at the Jack Mercer Bandstand for the Holiday Sing from 6:00 p.m. to 9:00 p.m.

Mayor pro Tem Wapner had no comments.

Council Member Bowman commented on efforts of the non-profit Christmas on Euclid Experience in offering the Christmas Tree Lighting at Town Square and the beauty of the Christmas decorations along Euclid Avenue.

Council Member Valencia commended the Police and Fire Departments for their work on a rescue he witnessed on Saturday evening. He commented that he was glad to say that Ontario puts public safety first to save citizens' lives.
