JOINT MEETINGS

Regular meetings of the Ontario City Council/Ontario Housing Authority were held on Tuesday, August 21, 2018, at the Ontario City Hall, 303 East B Street, Ontario, California.

CLOSED SESSION

Mayor Leon called the City Council and Housing Authority meetings to order at 6:02 p.m., with all members present except Council Member Bowman (an excused absence); and inquired whether persons were present who wished to speak to the Closed Session item. Hearing no one, the City Council recessed to Closed Session at 6:02 p.m. for discussion of the following:

Mayor Leon called the City Council and Housing Authority meetings to order at 6:30 p.m., and requested the City Clerk call the roll.

Also present were City Manager/Executive Director Scott Ochoa, City Attorney/Legal Counsel John Brown and City Clerk/Secretary Sheila Mautz.

CLOSED SESSION REPORT

City Attorney Brown reported that the matter listed on the agenda was discussed and direction was given to the real property negotiator, however there was no reportable action.

The Pledge of Allegiance was led by Council Member Dorst-Porada.

In the absence of the Pastor, Mayor Leon called for a moment of silence.

PUBLIC COMMENTS

Rita Nelsen, noted that she is a resident of Rancho Ontario Mobile Home Park and thanked Police, Fire and the City Council for their visits during the Ontario Night Out event at Rancho Ontario Mobile Home Park.

Mayor Leon noted that this year there were over thirty parties citywide for Ontario Night Out, so the Council had to split up to attend them all.

Rudy Favila, expressed concern with the early posting of campaign signs, and he also suggested a need for a candidate debate or forum.

Jesse Fonseca, expressed ongoing concern with airplane noise over his house from the Ontario Airport.

Paul MimMack, requested a candidate's debate.

Peggi Hazlett, representing the Greater Ontario Business Council, introduced new Board Members and explained that their current focus is on manufacturing businesses. She highlighted an event held today featuring a mobile bearing manufacturing unit. She also announced upcoming events and noted that they will be kicking off a partnership with Cal State Fullerton.

Richard Galvez, expressed pride in the work of the De Anza students being recognized this evening, as well as the teachers and leadership of the school and district.

Benjamin Lopez, Outreach Director for FrontSight Military Outreach, announced events recognizing 9/11 including a Remembrance Day on September 8, 2018 and a Golf Fundraiser on September 12, 2018. Mayor Leon noted for the public that this organization is a ministry for Veterans.

SPECIAL CEREMONIES

RECOGNITION OF DE ANZA MIDDLE SCHOOL - WATER FOR SOUTH SUDAN PROJECT

Helen McAlary, Executive Director of Community Life and Culture, expressed that once goal of her agency is to strengthen ties within the community, and the Ontario-Montclair School District (OMSD) has been a great partner in that effort. She introduced De Anza Middle School teacher, *Martha Banuelos*, and her students responsible for this project.

Ms. Banuelos thanked OMSD leaders and her school principal for their support and noted that this project was undertaken by the 7th grade English Department at De Anza Middle School. The project raised funds for a water well in South Sudan, Africa. Students Aldo

Rojas, Barisa Ayala and Kevin Mendoza provided an overview of their efforts on the project. Ms. Banuelos noted that the school is now working to raise money for a second well. Mayor Leon called the group forward for a presentation and photographs.

City Council authorized the City Manager to execute an amendment to the Maintenance Services Agreement with Merchants Building Maintenance of Pomona, California, extending the contract term to June 30, 2019 and adding \$106,394 of additional funding for an amended annual contract amount of \$585,950 plus contingency of \$10,000; authorized the addition of future services; and authorized the option to extend the agreement for an additional option year consistent with the City Council approved budgets.

STAFF MATTERS

City Manager Ochoa had no comments.

COUNCIL MATTERS

Mayor Leon noted Item #4 of this agenda and recognized Recreation/Community Services Director Dorey and members of the Teen Action Committee in the audience, with regard to the new "no smoking in parks ordinance". He noted that several people expressed anger about the City infringing on their right to smoke in public, but Leon stressed that smokers are infringing on the rights of non-smokers. Ms. Dorey expressed pride in the work of the students who brought this ordinance forward. Mayor pro Tem Wapner commended the students for putting others before themselves. Council Member Dorst-Porada expressed pride in the efforts of these students and thanked them for helping make Ontario a better city. Council Member Valencia also commended the students and noted the impacts of second hand smoke and cancer.

Mayor Leon inquired of Ms. Dorey as to how encompassing this ordinance would be. Ms. Dorey indicated that it would prohibit all smoking in all parks, except the golf course. Mayor Leon inquired how it would be policed. Ms. Dorey indicated that they are working with the City Attorney and Police Department on enforcement guidelines, and reiterated that it will help to make the parks safer over all. Mayor Leon suggested that the public be made aware of the new rules through social media.

Council Member Valencia commented on Ontario Night Out and commended Police, Fire and City staff on an amazing job.

Mayor pro Tem Wapner commented that the entire City Council makes public safety a priority and indicated that Item #10 of this agenda was the purchase of \$4 million in additional fire equipment. He also noted that Council Member Bowman was absent this evening due to the loss of his brother, and requested that everyone keep his family in their prayers.

Council Member Dorst-Porada showed the "Ontario Living" magazine and commented on the number of programs offered by the City. She highlighted the disaster preparedness and CERT programs being offered, and noted that she would not be in attendance at the September 18, 2018 City Council meeting as she would be attending an upcoming Extreme Tabletop Event.

Mayor Leon commented that everything he had wanted to say had already been covered and noted that is what a good team does. He also spoke on the increase in public discussion the month or two before an election, and expressed his belief that Ontario continues to get better. He indicated his belief that City staff is second to none and working as a team, continues to improve.

Mayor Leon adjourned the meetings of the Joint Agencies at 7:43 p.m. and announced the next regular meetings to be held on Tuesday, September 4, 2018.
