Households must meet at least two of the following risk factors for homelessness to be eligible to receive direct financial assistance for homelessness prevention.

1. Eviction within two weeks from a private dwelling (including housing provided by family or friends);
2. Sudden and significant loss of income;
3. Sudden and significant increase in utility costs or other necessary expenses (such as medical care);
4. Severe housing cost burden (greater than 50% of income for housing costs);
5. Homeless in the last 12 months;
6. Pending foreclosure of rental housing;
7. Young head of household (under 25 with children or pregnant);
8. Extremely low income (less than 30% of area median income);
9. Recent traumatic life event, such as death of a spouse or primary care provider, or recent health crisis that prevented the household from meeting its financial responsibilities; or
10. Recent change in familial status, such as divorce.

This criteria will be used to screen all applicants seeking direct financial assistance for homelessness prevention. The criteria were chosen to direct the assistance to the neediest persons/households in the community who may not have the resources needed to prevent homelessness on their own, but who also would be the most likely to maintain their housing after the assistance period has ended.
