Executive Summary*

I. EXECUTIVE SUMMARY

A. Purpose of the Five-Year Consolidated Plan

Ontario's Consolidated Plan identifies the City's overall housing and community development needs and outlines a strategy to address them. The primary purpose of the Consolidated Plan is to match HUD resources from Community Development Block Grant (CDBG), HOME Investment Partnership (HOME), and Emergency Solutions Grant (ESG) with the identified needs and strategies. The Consolidated Plan provides a centralized analysis of community needs coupled with a five-year strategy for addressing these needs. The current Consolidated Plan covers the period from July 1, 2010 through June 30, 2015.

B. Summary of the Five-Year Strategy

The key component of the Consolidated Plan is the Strategic Plan. The strategy is a combination of an inventory of resources available to meet housing and community development needs, with long-range measurable goals. The One-Year Action Plan, which is an annual component of the Consolidated Plan, has specific targets and identifies the resources available to be committed to various projects and programs for implementation within the upcoming year.

The foundation for each strategy is a list of priorities for both housing and community development activities. Each set of priorities was developed in response to the issues identified in the Needs Assessment Section of the Five-Year Consolidated Plan.

Housing Strategy

- Goal #1:** Preserve and rehabilitate existing rental and owner-occupied housing resources.
- Goal #2:** Increase affordable homeownership opportunities, particularly for low- and moderate-income persons.
- Goal #3:** Expand affordable rental housing opportunities, particularly for low-income persons.

Homeless Strategy

- Goal #1:** Preserve and improve the supply of supportive housing and public services for the homeless and homelessness prevention services.

Special Needs Strategy

- Goal #1:** Provide supportive services for special needs population.

Fair Housing Strategy

- Goal # 1:** Continue to implement the Fair Housing laws by providing funding to further fair housing.

Public Housing Strategy

Goal #1: Continue to support the on-going efforts of the Housing Authority of the County of San Bernardino and the Ontario Housing Authority to maximize the use of Section 8 subsidies and other resources in the City.

Based upon the local priorities and available funding, the City of Ontario City Council has determined the following distribution of CDBG, HOME, and ESG funds to the following programs:

1. Housing Strategy

Goal #1: Preserve and rehabilitate existing rental and owner-occupied housing units.

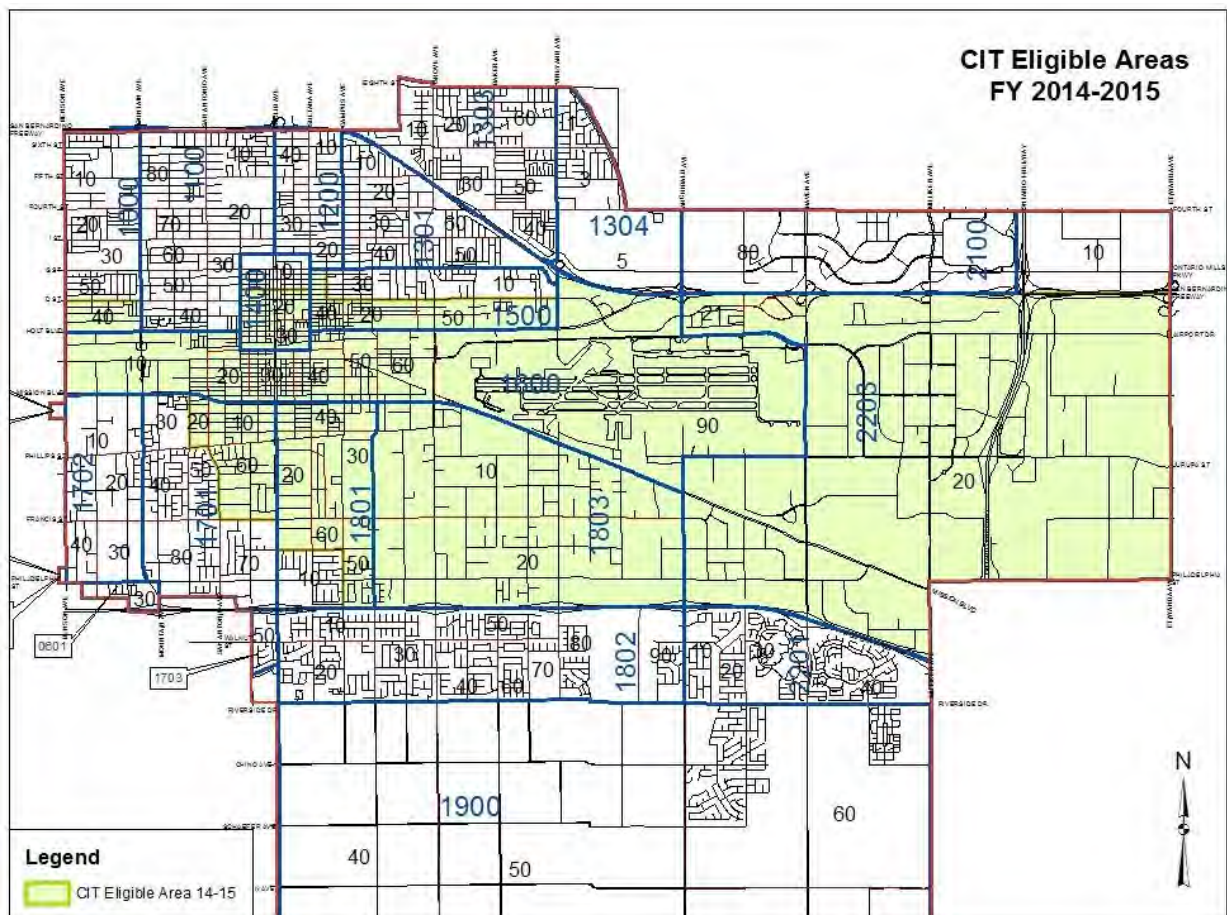
Program: Community Improvement Team
Agency: City of Ontario Code Enforcement Department
Service Area: Targeted Low/Mod Areas

The Community Improvement Team has been specifically designed to pro-actively implement an intensive code compliance program to address serious code violations within eligible targeted low/mod areas that have been identified as deteriorated areas that are having

a significant impact on the existing neighborhoods. The boundaries of the area where CIT activities are eligible for CDBG-funding can be found in the map below and in the Maps Appendix. Costs incurred for inspections of code violations and the enforcement of code requirements for properties located within eligible focus block groups are eligible for CDBG funding. To ensure long-term program solutions, the team coordinates the resources available within the various City Departments, including but not limited to the following: Police, Fire, Code Enforcement, Planning, Economic Development, and Housing.

CIT efforts will be coordinated with the delivery of these other programs to arrest decline in neighborhoods:

- Quiet Home Residential Sound Insulation Program funded with monies from Los Angeles World Airports (LAWA) and Federal Aviation Administration (FAA),
- Quiet Home Owner-Occupied Rehabilitation Program funded with State of California CalHome funds and CDBG,
- State of California Downtown Core Catalyst Project funded under the Catalyst Projects for California Sustainable Strategies Pilot Innovative Housing Program, and
- Mortgage Assistance Program funded with State of California CalHome funds.



Goal #2: Increase affordable homeownership opportunities, particularly for low- and moderate-income persons.

Program: Community Housing Development Organizations (CHDOs) Housing Program
Agency: City of Ontario Housing and Municipal Services Agency
Service Area: Citywide

This program is designed to preserve, enhance, and improve existing neighborhoods through acquisition, rehabilitation and/or new construction activities through Community Housing Development Organizations (CHDOs). The City of Ontario Housing and Municipal Services Agency will accept applications for financial assistance from certified CHDOs for proposed high quality housing projects that will enhance the City's efforts to create and preserve a variety of housing opportunities for Ontario residents with a range of affordability requirements including:

- Single-Family For-Sale Housing (Acquisition, Rehabilitation, Resale);
- Single-Family For-Sale Housing (New Construction)
- Multi-Unit Acquisition and Rehabilitation (Family and Senior Housing); and
- Multi-Unit (New Construction Family and Senior Housing).

Resale

All HOME assisted units will be restricted to households at or below 80% of area median income adjusted for family size. The City will record covenants that meet the HOME affordability requirements given the activity and funding level.

The maximum amount of HOME-funds per unit will be restricted to the dollar limit established under 221(d)(3)(ii) of the National Housing Act (12 U.S.C. 17151 (d)(3)(ii)).

Goal #3: Expand affordable rental housing opportunities, particularly for low-income persons.

Program: Tenant Based Rental Assistance Program
Agency: City of Ontario Housing and Municipal Services Agency
Service Area: Citywide

This program is designed to assist chronically homeless individuals obtain and maintain permanent housing units. The program will provide direct financial assistance to each participant up to \$15,000, including security and utility deposits. If the tenant is required to pay utilities, this would be deducted from the gross allowed rental cost to determine if the unit is eligible. Unit rental cost must be supported by a review of comparable rental costs of similar units within the neighborhood. Program would be restricted to Ontario's chronically homeless as verified by Code Enforcement Department.

Eligibility is restricted to households with a maximum income at or below 50% of area median income and a minimum monthly income of \$350 or utility allowance for the selected

housing unit plus \$100, whichever is greater. Eligible tenants must be homeless and meet one of the following conditions:

- Current permitted client of the Ontario Access Center (OAC); or
- Current resident of a transitional housing facility currently funded by the City of Ontario; or
- Current participant in a homeless services program funded by a permitted service provider for the OAC and/or other homeless service program funded by the City of Ontario.

In addition, eligible tenants must currently meet one of the following criteria, or have met one of the following criteria prior to entering a transitional housing facility:

- Sleeping in an emergency shelter;
- Sleeping in a place not meant for human habitation, such as cars, parks, abandoned buildings, streets/sidewalks;
- Staying in a hospital or other institution for up to 180 days but was sleeping in an emergency shelter or other place not meant for human habitation (cars, parks, streets, etc.) immediately prior to entry into the hospital or institution;
- Graduating from, or timing out of a transitional housing program; and
- Victims of domestic violence.

Finally, eligible participants must be a resident of the City of Ontario, verified through the last permanent address provided by the applicant through a driver's license, a rent receipt, court records, etc.

The Program will provide no more than a two month security deposit and minimum utility deposits. No pet security deposits or rental increases due to pet costs. Assistance will be provided for 12 months with an option for a 12-month extension, dependent upon availability. All deposits will be required to be returned to Ontario at end of assistance or the participant will enter into a loan agreement with Ontario for security deposit amount.

The following payment standard will be used in determining maximum rental amounts for each available bedroom size. This standard is intended to represent the rental cost of moderately priced units within the City of Ontario that meet Section 8 Housing Quality Standards ("HQS").

2. Homeless Strategy

Goal #1: Preserve and improve the supply of supportive housing and public services for the homeless.

Program: Mercy House Continuum of Care
Agency: Mercy House Living Centers, Inc.
Service Area: Citywide

Mercy House operates a complete continuum of care within Ontario, including an Access Center, transitional housing, and affordable permanent housing designed to meet the needs of the homeless at every stage of their struggle. The Ontario Access Center provides safety-net and housing stabilization services to the homeless and at-risk of homeless. Services at the Center include lockers, laundry facilities, food distribution, showers, and meeting spaces. Assisi House transitional shelter provides transitional housing and supportive services to single men, single women, and single mothers with their children. The affordable permanent housing programs, housing voucher programs, including the Shelter Plus Care program, and aftercare program in Ontario provide continued care and support to those in need, a lasting end to their homelessness. Together these programs form a complete continuum of care, a system designed to end homelessness.

Program: Sova Food Security Program
Agency: Inland Valley Council of Churches, dba Inland Valley Hope Partners
Service Area: Citywide

Inland Valley Hope Partners' Food Security Program helps families living in poverty maintain their health, stretch their food dollars, and avoid homelessness by providing emergency food, support services and advocacy. The Sova Program Center in Ontario serves the west end of San Bernardino County. The program provides low and very low income and homeless individuals and families with emergency food supplies and support services. Participants are able to obtain a four or five day supply of basic staple foods, enough to provide approximately 10-15 meals for each family member, every 30 days. Clients are also able to access additional support, such as hygiene products, diapers, and paper products. Utility and rental assistance may be accessed, as well as 3-5 day emergency motel vouchers (when available). Information and referral resources are available, especially in the areas of health services, housing, and other food programs.

Program: Stepping Stones Program
Agency: Foothill Family Shelter
Service Area: Citywide

Foothill Family Shelter (FFS) offers transitional housing in two-bedroom apartments, to at-risk homeless families, in conjunction with comprehensive supportive services. The goal is to meet the immediate needs of people in crisis, and promote new behavior. FFS focuses on financial education, mandatory savings, professional counseling, basic life skills and literacy development. Participants achieve measurable success due to staff's implementation of individual housing and treatment case plans, which outline goals and steps so that participants secure permanent housing, achieve employment success, and maintain

significant savings. The Stepping Stones Program (SSP) provides families with a fully furnished, rent free, two-bedroom apartment for 120 days. If they successfully complete SSP, they are offered 1-year housing in our 28-unit apartment complex. Participants are required to attend weekly case management and counseling meetings. They must save 50% of their income. Participants must remain drug and alcohol free during their stay. Measurable success is achieved because of the individual attention each client receives. In addition to SSP, FFS also operates a food pantry program which provides food, diapers, and personal hygiene items to low-income families within their service area.

Program: Services for Battered Women and Their Children
Agency: House of Ruth, Inc.
Service Area: Citywide

House of Ruth is a non-profit domestic violence agency, serving battered women and their children for more than 35 years. Services are provided through the agency's 24-hour crisis hotline, at conveniently located walk-in centers in Ontario and Pomona, and at House of Ruth's emergency and transitional shelters. Safety and self-sufficiency are the focus of all of House of Ruth's programs. The hotline provides crisis counseling, intake to shelter and referral to community services. Women in both residential and non-residential programs are provided with case management, individual and group counseling, safety planning, assistance with accessing mainstream social services, assistance with filing a restraining order, and help with employment and housing needs. Their children may be referred to House of Ruth's Child Abuse Treatment program for therapeutic counseling. Women at the Emergency Shelter also receive emergency transportation, clothing, and all meals. Domestic violence prevention education brings awareness of domestic violence to local communities.

3. Fair Housing Strategy

Goal #1: Continue to implement Fair Housing laws by providing funding to further fair housing.

Program: Fair Housing and Mediation Services
Agency: Inland Fair Housing and Mediation Board
Service Area: Citywide

Inland Fair Housing and Mediation Board (IFHMB) will provide the residents of the City of Ontario with a comprehensive program committed to Fair Housing Education, Outreach and Enforcement. IFHMB will perform its work to align with the City's Analysis of Impediments and provide monthly data reports with relevant and pertinent information relating to services provided to its residents. IFHMB will also provide technical assistance to City staff, enabling them to incorporate activities that affirmatively further fair housing.

A comprehensive Landlord/Tenant program that includes counseling, information dissemination, mediation and/or referral of Landlord/Tenant issues will also be provided. All Ontario citizens will be advised of their fair housing rights under both Federal and State law.

In addition, IFHMB has expanded its fair housing and mediation work to specifically address the needs of the City of Ontario's senior population with both fair housing and

landlord/tenant education related to topics on housing rights and responsibilities specific to senior needs. Seniors will be assisted with fair housing issues regarding age discrimination, reasonable accommodation/reasonable modification concerns, and complaints based on disability. The special needs of seniors will be a high priority as IFHMB assists these seniors with helping them to secure and maintain a safe and healthy landlord/tenant environment in which to live.

4. Community Development Strategy

Goal #1: Provide needed infrastructure improvements in target lower-and moderate-income neighborhoods.

Program: Pavement Management Rehabilitation Program
Agency: City of Ontario Engineering Department
Service Area: Various streets throughout eligible CDBG Area

This program will provide for approximately 500,000 square feet of street pavement rehabilitation that will lengthen the useful life of the street surface for more than 10 years. The work will be performed in the vicinity of Mountain Avenue and D Street and Sixth Street and Grove Avenue.

Program: Alley Pavement Rehabilitation Program
Agency: City of Ontario Engineering Department
Service Area: Census Tract 1400, Block Group 10, and Census Tract 1500, Block Groups 03 and 04

This program will provide for the rehabilitation of alley surface for the east-west alley that is north of F Street between Lemon Avenue and Berlyn Avenue and the alleys near Vineyard Avenue north of Fifth Street.

Program: Wheelchair Ramp Installation
Agency: City of Ontario Community and Public Services Agency
Service Area: Various locations

This project will include the installation of approximately eighty (80) wheelchair ramps and replacement of adjoining sidewalks.

Goal #2: Provide for new community facilities and improve the quality of existing community facilities to serve lower-and moderate-income neighborhoods.

Program: Energy Efficient Lighting at John Galvin Park Project
Agency: Housing and Municipal Services Agency
Service Area: Targeted Low/Mod Areas

This project will replace existing metal halide light fixtures with energy efficient induction light fixtures at Galvin Park. Energy efficient lighting fixtures have been rated to produce the same lumens and use approximately 50% less wattage of the existing light fixtures with a 100,000 hour warranty.

Program: Energy Efficient Lighting at Cypress Park Project
Agency: Housing and Municipal Services Agency
Service Area: Targeted Low/Mod Areas

This project will replace existing metal halide light fixtures with energy efficient induction light fixtures at Cypress Park. Energy efficient induction lighting fixtures have been rated to produce the same lumens and use approximately 50% less wattage of the existing light fixtures with a 100,000 hour warranty.

Program: James R. Bryant Park Restroom Renovation Project
Agency: Community and Public Services Agency
Service Area: Targeted Low/Mod Areas

This project will include rehabilitation to the existing roof due to termite and wind damage and installation of two (2) skylights to improve lighting for safety and security.

Program: Sam Alba Park Restroom Renovation Project
Agency: Community and Public Services Agency
Service Area: Targeted Low/Mod Areas

This project will include replacement of the restroom stalls, worn out sinks, urinals, and toilets, which are damaged and stained beyond cleaning.

Program: Galvin Park West Side Picnic Structure/BBQ Area Improvements and California Friendly Landscape Renovation
Agency: Community and Public Services Agency
Service Area: Targeted Low/Mod Areas

This project will include the removal of existing concrete pads west of the main shelter and installation of a California friendly planter with picnic tables and barbecues, installation of decomposed granite, and the retrofit of the rotting solid roof with a new aluma-wood trellis system that will attach to the existing shelter base.

Program: Galvin Park Renovation of Tennis Court to Futsal Court
Agency: Community and Public Services Agency
Service Area: Targeted Low/Mod Areas

This project will renovate the abandoned tennis court east of the restrooms and west of Grove Avenue to a futsal court. The renovation will include repairing the fencing and gates surrounding existing courts, update lighting with LED lamps and a timer, refurbish existing concrete to new play court system with striping according to NCAA standards, and provide goals and equipment for Recreation to start running programs and reservations. This project will help meet the growing demand for soccer and soccer type sports through the installation of a hard surface field area without the need for additional green space.

Goal #3: Provide needed community services to serve lower and moderate income residents.

Program: COPS Program
Agency: City of Ontario Police Department
Service Area: Targeted Low/Mod Areas

The C.O.P.S. Unit provides a variety of programs designed to develop community-based strategies for solving long-term community crime. This program includes the following services: Crime Free Multi-Housing Program, drug court, gang prevention program, SWEAT Program - anti-graffiti program, drunk driving prevention program for high school students, illegal street racing prevention program, and a number of innovative programs to prevent crime. In collaboration with the Alcohol Beverage Control Agency, the COPS Program educates local establishments in the regulation and responsibilities involved with the sale of alcohol. In addition, the COPS Program is involved in addressing other community issues including transients, prostitution, juvenile delinquency and truancy problems.

Program: Child Care, Family and Youth Subsidies
Agency: Ontario-Montclair YMCA
Service Area: Citywide

The Ontario-Montclair YMCA provides a before and after school childcare program for school aged boys and girls, who come from families of low to moderate incomes in the Ontario-Montclair and Mountain View School Districts. Children are provided with childcare before school, delivered to school, picked up after school, and transported to childcare sites in the afternoon. Throughout the year, programs for youth and families are provided that are both sport related and non-sport related. Families are not denied program entrance for their lack of ability to pay.

D. Amendments to the City Of Ontario Final Consolidated Plan FY 2014-2015 One-Year Action Plan

The Consolidated Plan is amended from time to time to address changes in the funding of projects; the location of projects; the addition of new projects; or the cancellation of projects. Any amendments to the Consolidated Plan will be processed in accordance with the Citizen Participation Plan and will be described in this section.

E. Housing and Community Development Resources

The City's ability to meet the housing, community development, and economic development needs depends largely on the availability of public and private sector resources.

The City of Ontario utilizes a variety of federal, state, and local resources to address identified housing and community development needs. The nature and scope of each particular project determines which source is most appropriate for each program. Table 3 summarizes the major sources of funding available to carry out housing and community development activities in Ontario, and identifies the City's current funding levels. This table provides a brief inventory of all resources offered by federal, state, and local entities. However, Table 3 is not an exhaustive

inventory, nor is it an inventory of all the resources, which the City of Ontario may necessarily use.

The table on the following pages details the City's efforts to leverage federal funds with non-federal funds for all of the proposed projects within the One-Year Action Plan.

G. Geographic Distribution

The specific location of housing and community development projects is a crucial issue. It is important that projects designed to clear blighting conditions are conducted in areas that are actually blighted, and that public service programs are provided at locations convenient to their clients. All HUD-funded activities will be implemented in low- and moderate-income service areas, as defined by HUD, with the exception of some public service projects, which are intended to serve CDBG-eligible persons on a citywide basis.

The City has established as a high priority, the investment of CDBG funds into targeted neighborhoods to help the City eliminate slum and blight conditions and improve the living conditions of the residents.

In order for an area to be considered as deteriorated or deteriorating the following conditions shall be met:

- A significant number of the properties located within the area must contain visible code violations affecting the property values in the area (such as lack of or insufficient landscaping, deteriorated paint, accumulations of debris, evidence of deferred maintenance, etc.);
- Infrastructure conditions that require attention (such as lack of sidewalks or sidewalks in disrepair, streets in disrepair, lack of or unmaintained street trees, etc.);
- May contain areas designated as targeted project areas;
- At least three of the five identified factors contributing to deterioration available through Census data shall be met
 - % of population below the poverty level $\geq 20\%$
 - % of vacant structures $\geq 5\%$
 - % of total occupied housing units that are overcrowded $\geq 20\%$
 - % of units lacking complete plumbing and/or kitchen facilities $\geq 1\%$
 - % of renter and/or owner occupied units experiencing a cost burden $\geq 30\%$
- Area must demonstrate that both public or private improvements and/or services will occur within the area.

H. Homeless Activities

The City of Ontario supports a variety of activities to address the needs of homeless persons and the special needs of persons that are not homeless but require supportive housing and special assistance. As part of the One-Year Action Plan, the City will support several programs and

projects conducted by non-profit social service providers. Each of these activities was specifically selected for funding through CDBG and ESG programs to address each step along the Continuum of Care. The City sought out proposals and applications from a variety of homeless and social service providers prior to allocating CDBG and ESG resources.

This region is fortunate to have a number of organizations, which serve both the general homeless population and specific special segments within the homeless community. In developing the funding allocation, the City supported a diverse selection of providers and cultivated cooperation among those groups in the delivery of their services.

During FY 2005-2006, the City of Ontario began implementing a new Continuum of Care program in coordination with Mercy House Living Centers to assist homeless individuals and families transition from homelessness to permanent housing. The Continuum provides a comprehensive homeless strategy to assist homeless individuals and families to become self-sufficient. The programs within the Continuum include the following services: the Ontario Access Center, 34 transitional housing units, permanent housing units, and an aftercare program. To date, the City of Ontario and Mercy House have completed comprehensive rehabilitation on the transitional housing units and 62 permanent housing units.

The City of Ontario worked in collaboration with HACSB and the Ontario Housing Authority to secure Shelter Plus Care (“S+C”) funding. Twelve (12) S+C vouchers have been awarded to assist qualified S+C households through an application referred to as “Project Gateway.”

Please refer to the following table for a summary analysis of available programs to assist homeless persons.

I. Public Housing

The City will continue to support the Housing Authority of the County of San Bernardino's (HACSB) Five-Year Goals/Accomplishments.

Public housing programs in Ontario are conducted through an agreement with the HACSB. The HACSB manages approximately 501 Section 8 vouchers within Ontario.

During FY 2014-2015, the City of Ontario Housing and Municipal Services Agency will continue to monitor affordable housing units at risk for conversion to market rate. Accordingly, it is the objective of the City that all assisted housing units that are eligible for conversion to non-low-income housing should be preserved.

In addition, the HACSB will continue to administer the Family Self-Sufficiency Program within the City during FY 2014-2015. In this program, residents sign a five-year contract with the HACSB. As incomes rise with new employment, savings accounts are established. After five years, the savings account is available to the household to pay for costs associated with independent living.

The City of Ontario worked in collaboration with HACSB and the Ontario Housing Authority to secure S+C funding. Twelve (12) S+C vouchers have been awarded to assist qualified S+C households through an application referred to as "Project Gateway."

As stated earlier, the City of Ontario and the Ontario Housing Authority are actively pursuing additional opportunities to secure project based vouchers to assist in neighborhood revitalization strategies that also support Ontario's Continuum of Care for the homeless.

J. Anti-Poverty Strategy

The City has included an Anti-Poverty/Vision for the Future Strategy within the Five-Year Consolidated Plan. In FY 2014-2015, the City will continue to aggressively implement programs and activities that will generate jobs and tax revenue to help reduce the number of persons that are currently below the poverty level.

K. Fair Housing Activities

In addition to the housing activities already discussed in the One-Year Action Plan, the City will address key fair housing recommendations and objectives identified in the Analysis of Impediments to Fair Housing Choice (AI).

The AI addresses five specific target groups, tenants and property purchasers, property owners and managers, realtors, lenders and local government. Recommendations, actions, and a time period for completion are presented for each target group.

L. Lead-Based Paint Hazards

The City will continue to implement the HUD regulations concerning lead-based paint testing and abatement. Currently, City staff informs residents of activities in any housing rehabilitation program about lead-based paint hazards. This policy applies regardless of whether there are children present in the households. Furthermore, all rehabilitation projects are administered in compliance with HUD regulations concerning lead-based paint testing and abatement.

Most of Ontario's housing stock was constructed prior to the 1978 ban on lead-based paint. Therefore, most units potentially contain lead-based paint. The City will continue to identify specific neighborhoods and households, which may contain lead-based paint hazards.

M. Monitoring Standards and Procedures

The City will enter into binding agreements with the subrecipients. Elements of these agreements will include the following information:

- A. Type of activity
- B. Scope of services to be provided
- C. Number of persons to be assisted
- D. Budget
- E. Reporting requirements
- F. Other terms and conditions

The City will conduct annual on-site inspections to ascertain whether the organization is actually meeting their goals and objectives. The overall goal will be to identify any deficiencies and promote corrections in order to improve performance.

For HOME Program projects, the City will continue to monitor the affordability provisions as outlined in the HOME Program agreements. Also, for projects that have one to four units, the City will conduct an on-site inspection every three years and for projects with five to twenty five

housing units, the City will conduct an on-site inspection every two years. For projects containing twenty-six housing units or more, a yearly inspection will be conducted.

N. Federal Match Requirements

The HOME Program requires a twenty-five (25%) percent match for every dollar drawn from the Federal Treasury. Funds set-aside for administration are exempt from this requirement.

In accordance with 24 CFR 92.222 of the HOME Program Regulations, HUD granted the City of Ontario a match reduction for HOME funds because the City has been designated as a fiscally distressed community. The City of Ontario received a fifty (50%) percent reduction of match for FY 2014-2015.

To qualify on the basis of fiscal distress, a jurisdiction must meet one of the following criteria: (1) a jurisdiction's family poverty rate must be 125 percent or more of the average national poverty rate or more than 12.4 percent or (2) the jurisdiction's per capita income (PCI) must be less than 75 percent of the national average or less than \$20,281. The jurisdictions that satisfy both of the distress criteria are determined to be in severe fiscal distress and receive a 100 percent reduction in match.

The City of Ontario received a 50% match reduction in that it satisfied one of the criteria as it was determined that the City's percent of families in poverty is 10.3 percent and its per capita income is \$19,534.

The Emergency Solutions Grant (ESG) requires a dollar-for-dollar match. Non-profit organizations receiving ESG funds will provide the required match.

O. Minority/Women Business Outreach

The City will continue its on-going efforts to inform target businesses about the opportunities associated with the expenditure of Federal funds for housing and community development.

P. Institutional Structure/Delivery System Gaps

The City of Ontario does not anticipate any gaps in the delivery of service based on the institutional structure of the City government, departments, or agencies. The City of Ontario Housing and Municipal Services Agency participates in a number of coalitions and collaborations to enhance coordination between the public and private housing and social service agencies providing services to Ontario residents. These coalitions include but are not limited to the following: County of San Bernardino Homeless Coalition, Inter-Agency Council on Homeless, and the HMIS Policy Advisory Board, and Housing Policy Advisory Committee.

Q. Coordination

The Ontario Housing and Municipal Services Agency consulted with other key City departments in developing this One-Year Action Plan. These departments included: City Manager's Office, Economic Development Department, Development Department, Planning Department, Community and Public Services Agency, Parks Department, Police Department, Fire Department, and Code Enforcement Department. City staff also consulted with the following

adjacent jurisdictions during the development of the One-Year Action Plan by providing them with a copy of the Draft One-Year Action Plan during the public review period: Upland, Chino, Rancho Cucamonga, Pomona, Fontana, and County of San Bernardino. Other key public and quasi-public agencies contacted in preparation of the plan included the County of San Bernardino Housing Authority, Upland Housing Authority, Ontario Housing Authority, and Inland Fair Housing and Mediation Board.

City of Ontario staff will continue to cooperate with other organizations in order to achieve housing and community development objectives. The following list identifies organizations that the City anticipates interacting with and, in some cases, providing funds to during the next fiscal year:

R. HOME – Specific Requirements

Resale/Recapture Provisions

CHDOs – Resale Restrictions

The City will place a minimum of a 45-year resale restriction on all homeownership properties purchased and rehabilitated with HOME Program (CHDO) funds. Resale restrictions will assure that the property will remain affordable to low-income households.

Affirmative Marketing - for rental projects consisting of five or more HOME assisted units; the City will adopt as required affirmative marketing procedures and requirements for all HOME housing projects with five or more units. Affirmative Marketing Plans will include the following elements:

- Methods for informing the public and owners and potential tenants about fair housing laws. The City will require that leasing agents utilize the fair housing logos and slogans in marketing units within properties consisting of five or more units.

- Description of efforts to be conducted to affirmatively market housing units assisted with HOME funds. Owners and leasing agents will place advertisements to market HOME-assisted units in appropriate publications, including, but not limited to local sources, public agencies, and local community groups.
- Description of outreach efforts to inform persons not likely to apply for housing without special outreach. These efforts will include comprehensive effort to distribute marketing materials to organizations that are likely to have contact with underserved populations.
- Maintenance of records to document actions taken to affirmatively market HOME-assisted units and to assess marketing effectiveness. Rental efforts will be periodically reviewed to ensure compliance with Affirmative Marketing Plan.
- Description of how affirmative marketing efforts will be assessed and what corrective actions will be taken where requirements are not met. Upon review of affirmative marketing efforts, if corrective actions are required the City will work with the owner and leasing agents to develop required corrective actions.

S. ESG – Specific Requirements

The City has adopted a process and criteria for awarding ESG. This process is conducted as part of the overall Consolidated Plan process. The City advertises the availability of CDBG, HOME, and ESG funds in a newspaper of general circulation. The criteria to select recipients are as follows:

- A. Ability of service provider to meet the intended use of ESG funds;
- B. Proposal is eligible;
- C. Proposal is consistent with the Continuum of Care principals found in applications for funding; and
- D. Ability to meet time frames required for obligation.

GENERAL DEFINITIONS USED WITHIN THE PLAN

Affordable Housing: Affordable housing is generally defined as housing where the occupants pay no more than thirty (30%) percent of gross income for gross housing costs, including utility costs.

Assisted Household or Person: For the purpose of specifying one-year goals for assisting households or persons, a household or person is assisted if, during the coming Federal fiscal year, they will benefit through one or more programs included in the jurisdiction's investment plan.

- A renter is benefited if the person takes occupancy of affordable housing that is newly acquired, newly rehabilitated, or newly constructed, and or receives rental assistance.
- An existing homeowner is benefited during the year if the home rehabilitation is complete.
- A first-time homebuyer is benefited if a home is purchased during the year.
- A homeless person is benefited during the year if the person is assisted by a service provided by a program which will assist in the transition from homelessness to permanent housing (i.e. financial assistance, case management, housing counseling and aftercare services).
- A non-homeless person with special needs is considered as being benefited, however, only if the provision of supportive services is linked to the acquisition, rehabilitation, or new construction of a housing unit and or the provision of rental assistance during the year.

Households or persons who will benefit from more than one program activity must be counted only once. To be included in the goals, the housing unit must, at a minimum, satisfy the HUD Section 8 Housing Quality Standards (see 24 CFR section 882.109). See also instructions for completing Table 3B of the CHAS and Table 1 of the Annual Performance Report.

Chronic Homeless: An individual or family that

- (i) is homeless and lives or resides in a place not meant for human habitation, a safe haven, or in an emergency shelter;
- (ii) has been homeless and living or residing in a place not meant for human habitation, a safe haven, or in an emergency shelter continuously for at least 1 year or on at least 4 separate occasions in the last 3 years; and
- (iii) has an adult head of household (or a minor head of o household if no adult is present in the household) with a diagnosable substance use disorder, serious mental illness, developmental disability (as defined in section 102 of the Developmental Disabilities Assistance and Bill of Rights Act of 2000 (42 U.S.C. 15002)), post traumatic street disorder, cognitive impairments resulting from a brain injury, or chronic physical illness or disability, including the co-occurrence of 2 or more of these conditions.

Committed: Generally means there has been a legally binding commitment of funds to a specific project to undertake specific activities.

Consistent with the Plan: A determination made by the jurisdiction that a program application meets the following criterion:

- The Annual Plan for that fiscal years funding indicates the jurisdiction planned to apply for the program or was willing to support an application by another entity for the program;
- The location of activities is consistent with the geographic areas specified in the plan; and
- The activities benefit a category of residents for which the jurisdictions five-year strategy shows a priority.

Cost Burden > 30%: The extent to which gross housing costs, including utility costs, exceed 30 percent of gross income, based on data published by the U.S. Census Bureau.

Cost Burden > 50%: (Severe Cost Burden): The extent to which gross housing costs, including utility costs, exceed 50 percent of gross income, based on data published by the U.S. Census Bureau.

Disabled Household: A household composed of one or more persons at least one of whom is an adult (a person of at least 18 years of age) who has a disability. A person shall be considered to have a disability if the person is determined to have a physical, mental or emotional impairment that:

- is expected to be of long-continued and indefinite duration;
- substantially impedes his or her ability to live independently; and
- is of such a nature that the ability could be improved by more suitable housing

A person shall also be considered to have a disability if he or she has a developmental disability as defined in the Developmental Disabilities Assistance and Bill of Rights Act (42 U.S.C. 6001-6006). The term also includes the surviving member or members of any household described in the first sentence of this paragraph who were living in an assisted unit with the disabled member of the household at the time of his or her death.

Elderly Household: For HUD rental programs, a one or two person household in which the head of the household or spouse is at least 62 year of age.

Elderly Person: A person who is at least 62 years of age.

Existing Homeowner: An owner-occupant of residential property who holds legal title to the property and who uses the property as his/her principal residence.

Family: A Family includes, but is not limited to, the following, regardless of actual or perceived sexual orientation, gender identity, or marital status:

- A single person, who may be an elderly person, displaced person, disabled person, near-elderly person, or any other single person; or
- A group of persons residing together and such group includes, but is not limited to:
 - (i) A family with or without children (a child who is temporarily away from the home because of placement in foster care is considered a member of the family;

- (ii) An elderly family;
 - (iii) A near elderly family;
 - (iv) A disabled family;
 - (v) A displaced family;
 - (vi) The remaining member of a tenant family.
- In addition, “family” shall include all families expressly described in 24 CFR 5.403, but shall expressly exclude a group including adults where each adult does not relate to the other adults by ties greater than mere friendship, unless such group can demonstrate that, despite such lack of ties, the group qualifies, collectively, as a “protected class” under the laws of any applicable jurisdiction.

First Time Homebuyer: An individual or family who has not owned a home during the three year period preceding the HUD-assisted purchase of a home that must be used as the principal residence of the homebuyer, except that any individual who is a displaced homemaker (as defined in 24 CFR 92) or a single parent (as defined in 24 CFR 921) may not be excluded from consideration as a first time homebuyer on the basis that the individual, while a homemaker or married, owned a home with his or her spouse or resided in a home owned by the spouse.

For Rent: Year round housing units that are vacant and offered/available for rent. (U.S. Census definition)

For Sale: Year round housing units that are vacant and offered/available for sale only. (U.S. Census definition)

Frail Elderly: An elderly person who is unable to perform at least 3 activities of daily living (i.e., eating, dressing, bathing, grooming, and household management activities). (See 24 CFR 689.105.)

Group Quarters: Facilities providing living quarters that are not classified as housing units. (U.S. Census definition) Examples include prisons, nursing homes, dormitories, military barracks, and shelters.

HOME: The HOME Investment Partnerships Program, which is authorized by Title 11 of the National Affordable Housing Act.

Homeless Family: Family that includes at least one parent or guardian and one child under the age of 18, a homeless pregnant woman, or a homeless person in the process of securing legal custody of a person under the age of 18, living in situations described by terms “sheltered” or “unsheltered”.

Homeless Individual: An unaccompanied youth (17 years or younger) or an adult (18 years or older) without children, living in situations described by terms “sheltered” or “unsheltered”.

Homeless Youth: Unaccompanied person 17 years of age or younger who is living in situations described by terms “sheltered” or “unsheltered”.

Household: One or more persons occupying a housing unit (U.S. Census definition). See also “Family”.

Housing Problems: Households with housing problems include those that: (1) occupy units meeting the definition of Physical Defects; (2) meet the definition of overcrowded; and (3) meet the definition of cost burden greater than 30%.

Housing Unit: An occupied or vacant house, apartment, or single room (SRO housing) that is intended as separate living quarters. (U.S. Census definition.)

Institutions/Institutional: Group quarters for persons under care or custody. (U.S. Census definition)

Large Related: A household of 5 or more persons that includes at least one person related to the householder by blood, marriage, or adoption.

Low-Income: Households whose incomes do not exceed 80 percent of the median income for the area, as determined by HUD, with adjustments for smaller and larger families, except that HUD may establish income ceilings higher or lower than 80 percent of the median for the area on the basis of HUD's findings that such variations are necessary because of prevailing levels of construction costs for fair market rents, or unusually high or low family incomes. NOTE: HUD income limits are updated annually and are available from local HUD offices. (This term corresponds to low and moderate-income households in the CDBG Program.)

Non-Elderly Household: A household, which does not meet the definition of “Elderly Household,” as defined above.

Non-Homeless Person with Special Needs: Includes elderly/frail elderly persons, persons with AIDS, disabled families, and families participating in organized programs to achieve economic self-sufficiency.

Non-Institutional: Group quarters for persons not under care or custody. (U.S. Census definition.)

Occupied Housing Unit: A housing unit that is the usual place of residence of the occupant(s).

Other Household: A household of one or more persons that does not meet the definition of a Small Related household, Large Related household, or Elderly Household.

Other Income: Households whose income exceeds 30 percent of the median income for the area, as determined by the Secretary, with adjustments for smaller and larger families.

Other Low-Income: Households whose incomes are between 51 percent and 80 percent of the median income for the area, as determined by HUD, with adjustments for smaller and larger families, except that HUD may establish income ceilings higher or lower than 80 percent of the median for the area on the basis of HUD's findings that such variations are necessary because of prevailing levels of construction costs or fair market rents, or unusually high or low family incomes. (This term corresponds to moderate-income in the CDBG Program.)

Other Vacant: Vacant year round housing units that is not For Rent or For Sale. This category would include Awaiting Occupancy or Held.

Overcrowded: A housing unit containing more than one person per room (U.S. Census definition.)

Owner: A household that owns the housing unit it occupies. (U.S. Census definition.)

Primary Housing Activity: A means of providing or production affordable housing – such as rental assistance, production, rehabilitation or acquisition – that will be allocated significant resources and/or pursued intensively for addressing a particular housing need. (See also, “Secondary Housing Activity”.)

Project-Based (Rental) Assistance: Rental assistance provided for a project, not for a specific tenant. Tenants receiving project-based rental assistance give up the right to that assistance upon moving from the project.

Rent Burden>30% (Cost Burden): The extent to which gross rents, including utility costs, exceeded 30 percent of gross income, based on data published by the U.S. Census Bureau.

Rent Burden> 50% (Severe Cost Burden): The extent to which gross rents, including utility costs, exceed 50 percent of gross income, based on data published by the U.S. Census Bureau.

Rental Assistance: Rental assistance payments provided as either project-based rental assistance or tenant-based rental assistance.

Renter: A household that rents the housing unit it occupies, including both units rented for cash and units occupied without cash payment of rent. (U.S. Census definition.)

Renter Occupied Unit: Any occupied housing unit that is not owner occupied, including units rented for cash and those occupied without payment of cash rent.

Secondary Housing Activity: A means of providing or producing affordable housing such as rental assistance, production, rehabilitation or acquisition – that will receive fewer resources and less emphasis than primary housing activities for addressing a particular housing need. (See also, “Primary Housing Activity”.)

Service Needs: The particular service’s identified for special needs populations, which typically may include transportation, personal care, housekeeping, counseling, meals, case management, person emergency response, and other services to prevent premature institutionalization and assist individuals to continue living independently.

Severe Cost Burden: The extent to which gross housing costs, including utility costs, exceed 50 percent of gross income, based on data available from the U.S. Census Bureau.

Severe Mental Illness: A serious and persistent mental or emotional impairment that significantly limits a person's ability to live independently.

Sheltered: Families and persons whose primary nighttime residence is a supervised publicly- or privately-operated shelter including emergency shelters, transitional housing for the homeless, domestic violence shelters, residential shelters for runaway and homeless youth, and any hotel/motel/apartment voucher arrangement paid because the person is homeless. This term does not include persons living doubled up or in overcrowded or substandard conventional housing. Any facilities offering permanent housing are not a shelter, nor are its residents homeless.

Small Related: A household of 2 to 4 persons, which includes at least two related persons.

Standard Condition: "Standard Condition" by local definition means units that are well maintained and in good condition with no repairs needed.

Substandard Condition but not Suitable for Rehab: By local definition, dwelling units that are such poor condition as to be neither structurally nor financially feasible for rehabilitation.

Substandard Condition but Suitable for Rehab: By local definition, dwelling units that do not meet standard conditions but are both financially and structurally feasible for rehabilitation. This does not include units that require only cosmetic work, correction or minor livability problems or maintenance work.

Substantial Amendment: A major change in a housing strategy submitted between scheduled annual submissions. For the purpose of the Consolidated Plan, a “substantial change” is:

- a) a net increase greater than 100% of the activity allocation if the allocation is \$50,000 or more as listed in a published One-Year Action Plan, or as amended; or
- b) a net increase greater than \$50,000 of the activity allocation if the allocation is less than \$50,000 as listed in a published One-Year Action Plan, or as amended; or
- c) a net increase or decrease in an activity allocation greater than \$300,000; or
- d) a new activity not previously described in a published One-Year Action Plan, or as amended.

Substantial Rehabilitation: Rehabilitation costs in excess of 25% of the after-rehabilitated value including land.

Supportive Housing: Housing with a supporting environment, such as group homes or Single Room Occupancy (SRO) housing and other housing that includes a planned service component.

Supportive Service Need in FSS Plan: The plan that PHAs administering a Family Self-Sufficiency program are required to develop to identify the services they will provide to participating families and the source of funding for those services. The supportive services may include child care; transportation; remedial education; education for completion of secondary or post secondary schooling; job training, preparation and counseling; substance abuse treatment and counseling; training in homemaking and parenting skills; money management, and household management; counseling homeownership; job development and placement; follow-up assistance after job placement; and other appropriate services.

Supportive Services: Services provided to residents of supportive housing for the purpose of facilitating the independence of residents. Some examples are case management, medical or psychological counseling and supervision, childcare, transportation, and job training.

Tenant Assistance: Rental assistance payments provided as either project-based rental assistance or tenant-based rental assistance.

Tenant-Based (Rental) Assistance: A form of rental assistance in which the assisted tenant may move from a dwelling unit with a right to continued assistance. The assistance is provided for the tenant, not the project.

Transitional Housing: A project that is designed to provide housing and appropriate supportive services to homeless persons to facilitate movement to independent living within 24 months, or a longer period approved by HUD. For purposes of the HOME program, there is no HUD-approved time period for moving to independent living.

Total Vacant Housing Units: Unoccupied year round housing units. (U.S. Census definition)

Unit of general local government: A city, town, township, county, parish, village, or other general purpose political subdivision of a State; an urban county; the Federated States of the Micronesia and Palau, the Marshall Islands, or a general purpose political subdivision therefore; and a consortium of such political subdivisions recognized by HUD in accordance with the HOME program (part 92) or the CDBG Program (part 570).

Unsheltered: Families and individuals whose primary nighttime residence is a public or private place not designed for, or ordinarily used as, a regular sleeping accommodation for human beings (e.g., the street, sidewalks, cars, vacant and abandoned buildings).

Vacant Awaiting Occupancy or Held: Vacant year round housing units that have been rented or sold and are currently awaiting occupancy, and vacant year round housing units that are held by owners or renters for occasional use. (U.S. Census definition)

Vacant Housing Unit: Unoccupied year-round housing units that is available or intended for occupancy at any time during the year.

FFS focuses on financial education, mandatory savings, professional counseling, basic life skills and literacy development. Participants achieve measurable success due to staff's implementation of individual housing and treatment case plans, which outline goals and steps so that participants secure permanent housing, achieve employment success, and maintain significant savings. The Stepping Stone Program (SSP) provides families with a fully furnished, rent free, two-bedroom apartment for 120 days. If they successfully complete SSP, they are offered 1-year housing in our 28-unit apartment complex. Participants are required to attend weekly case management and counseling meetings. They must save 50% of their income. Participants must remain drug and alcohol free during their stay. In addition to SSP, FFS also operates a food pantry program which provides food, diapers, and personal hygiene items to low-income families within their service area.

Anti-displacement and Relocation Plan – It will comply with the acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended, and implementing regulations at 49 CFR 24; and it has in effect and is following a residential anti-displacement and relocation assistance plan required under section 104(d) of the Housing and Community Development Act of 1974, as amended, in connection with any activity assisted with funding under the CDBG or HOME programs.

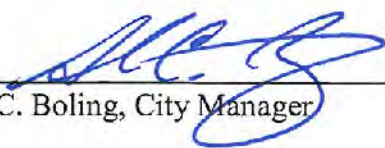

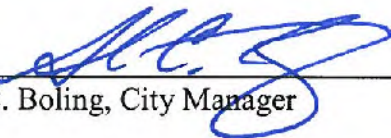

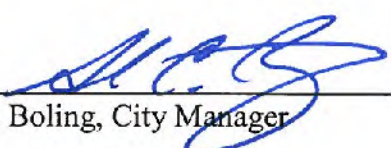

ESG Certifications

The Emergency Solutions Grants Program Recipient certifies that:

Major rehabilitation/conversion – If an emergency shelter's rehabilitation costs exceed 75 percent of the value of the building before rehabilitation, the jurisdiction will maintain the building as a shelter for homeless individuals and families for a minimum of 10 years after the date the building is first occupied by a homeless individual or family after the completed rehabilitation. If the cost to convert a building into an emergency shelter exceeds 75 percent of the value of the building after conversion, the jurisdiction will maintain the building as a shelter for homeless individuals and families for a minimum of 10 years after the date the building is first occupied by a homeless individual or family after the completed conversion. In all other cases where ESG funds are used for renovation, the jurisdiction will maintain the building as a shelter for homeless individuals and families for a minimum of 3 years after the date the building is first occupied by a homeless individual or family after the completed renovation.

Essential Services and Operating Costs – In the case of assistance involving shelter operations or essential services related to street outreach or emergency shelter, the jurisdiction will provide services or shelter to homeless individuals and families for the period during which the ESG assistance is provided, without regard to a particular site or structure, so long as the jurisdiction serves the same type of persons (e.g., families with children, unaccompanied youth, disabled individuals, or victims of domestic violence) or persons in the same geographic area.

Renovation – Any renovation carried out with ESG assistance shall be sufficient to ensure that the building involved is safe and sanitary.

Supportive Services – The jurisdiction will assist homeless individuals in obtaining permanent housing, appropriate supportive services (including medical and mental health treatment, victim services, counseling, supervision, and other services essential for achieving independent living), and other Federal, State, local, and private assistance available for such individuals.


Matching Funds – The jurisdiction will obtain matching amounts required under 24 CFR 576.201.

Confidentiality – The jurisdiction has established and is implementing procedures to ensure the confidentiality of records pertaining to any individual provided family violence prevention or treatment services under any project assisted under the ESG program, including protection against the release of the address or location of any family violence shelter project, except with the written authorization of the person responsible for the operation of that shelter.

Homeless Persons Involvement – To the maximum extent practicable, the jurisdiction will involve, through employment, volunteer services, or otherwise, homeless individuals and families in constructing, renovating, maintaining, and operating facilities assisted under the ESG program, in providing services assisted under the ESG program, and in providing services for occupants of facilities assisted under the program.

Consolidated Plan – All activities the jurisdiction undertakes with assistance under ESG are consistent with the jurisdiction's consolidated plan.

Discharge Policy – The jurisdiction will establish and implement, to the maximum extent practicable and where appropriate policies and protocols for the discharge of persons from publicly funded institutions or systems of care (such as health care facilities, mental health facilities, foster care or other youth facilities, or correction programs and institutions) in order to prevent this discharge from immediately resulting in homelessness for these persons.

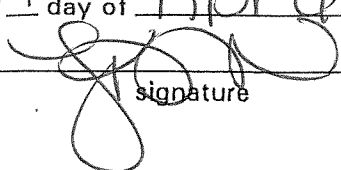

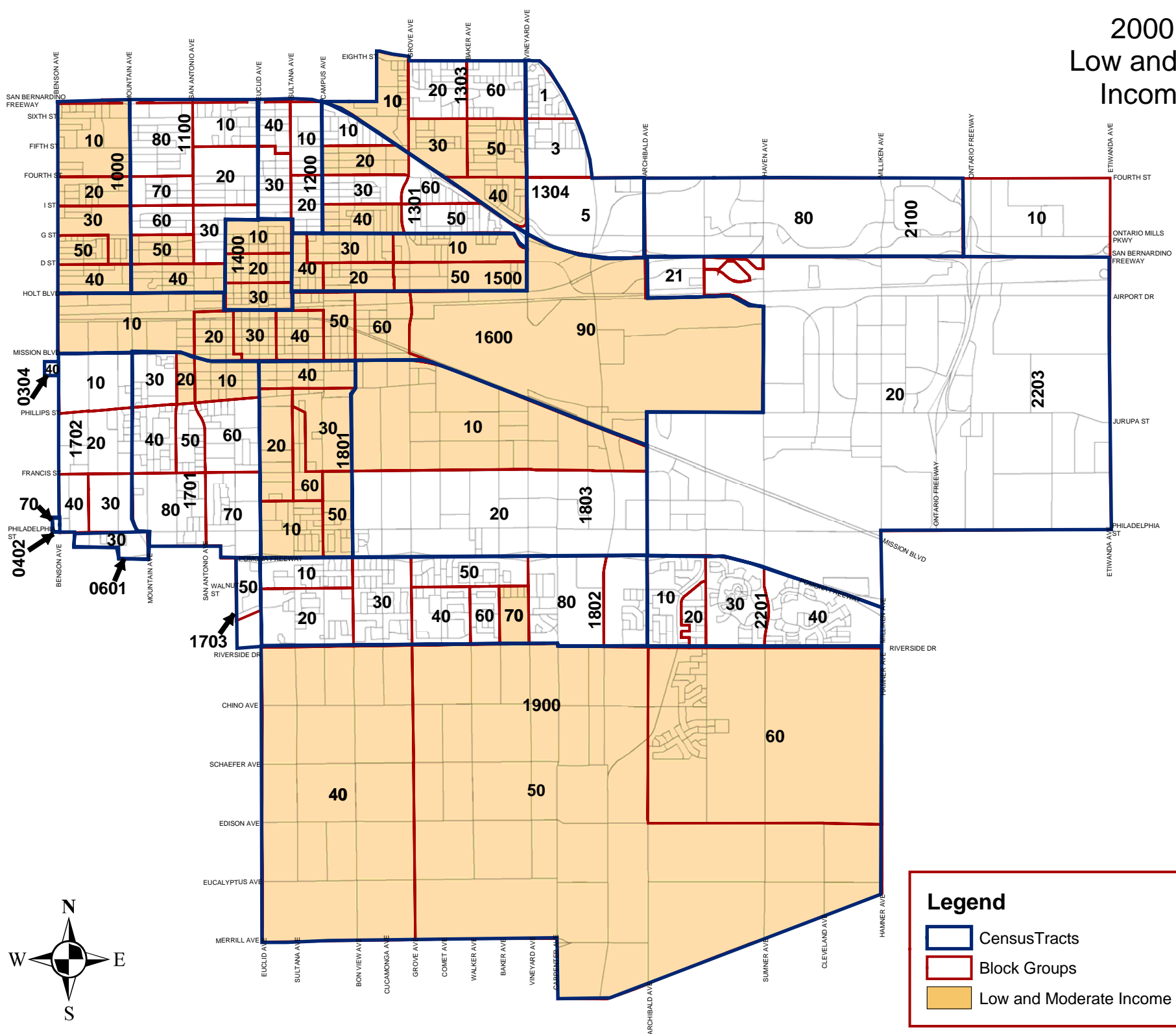
