# B. <u>ENVIRONMENTAL ASSESSMENT AND SPECIFIC PLAN AMENDMENT REVIEW</u>

FOR FILE NO. PSPA22-007: A public hearing to consider an Amendment to the Grove Avenue Specific Plan changing the land use designation of 4.20 acres of land from Office/Commercial to Business Park for property located at 2042 S. Grove Avenue. An Addendum to The Ontario Plan (TOP) 2050 Supplemental Environmental Impact Report (State Clearinghouse No. 2021070364), which was certified by the City Council on August 16, 2022, was prepared. This application introduces no new significant environmental impacts. The proposed project is located within the Airport Influence Area of Ontario International Airport and was evaluated and found to be consistent with the policies and criteria of the Ontario International Airport Land Use Compatibility Plan; (APN:105-049-111) submitted by First Industrial Realty Trust. City Council action is required.

Mr. Noh stated a public comment had been received for this item.

Senior Planner Batres, presented the staff report. He stated that staff is recommending the Planning Commission recommend approval of the Addendum and File No. PSPA22-007, pursuant to the facts and reasons contained in the staff report and attached resolutions, and subject to the conditions of approval.

## **PUBLIC TESTIMONY**

Paul Loubet, with First Industrial Realty Trust, thanked staff, and spoke about the project.

Ms. DeDiemar asked if the applicant agreed with the conditions of approval.
