**BACKGROUND:** The City's boards, commissions, and committees have been operating under expectations and rules of conduct contained in multiple documents including the Ontario Municipal Code, board bylaws, commission rules and procedures, and the Ralph M. Brown Act. To help ensure overall consistency in expectations, staff recommends that the City Council approve a single handbook with those components applicable to all of the City's advisory bodies. The purpose of this handbook is to assist board, commission, and committee members in understanding the responsibilities of the body on which they have been asked to serve and their role as envisioned by the City Council. The handbook contains general information on the City's organization and structure, a description of duties and powers for the advisory bodies, procedural guidelines and specific Ontario Municipal Code sections relative to each body. The handbook was developed with staff input representing the Planning Department, Recreation & Community Services Department, Library, and Museum of History and Art.

Additionally, the Fair Political Practices Commission (FPPC) recently adopted new regulations clarifying reporting requirements for public agencies and officials regarding the distribution of tickets and/or passes. The proposed policy update ensures that all tickets and/or passes provided to the City shall be distributed in furtherance of governmental and/or public purposes and disclosed in accordance with the new changes to applicable State law.

# SUBJECT: A RESOLUTION FOR PLACEMENT OF SPECIAL ASSESSMENTS ON COUNTY TAX ROLLS

**RECOMMENDATION:** That the City Council adopt a resolution for recovery of fees and costs incurred in abating property and dangerous building violations as well as administrative citations and civil penalties associated with property maintenance violations, and placing special assessments on County tax rolls.

#### COUNCIL GOALS: <u>Develop Strategies and Take Actions to Minimize the Negative Impacts of</u> <u>the Global Financial Downturn on Ontario's Economy and the City's Fiscal Health</u> <u>Operate in a Businesslike Manner</u>

**FISCAL IMPACT:** The levy of special assessments will result in the recovery of \$60,689 in costs the City has expended for inspection or abatement as well as the collection of \$321,430 associated with civil penalties and/or fines for continued violations for a total of \$382,119 related to 188 parcels. When received, reimbursement will be made to the General Fund \$367,986 and the Dangerous Building Fund \$14,133.

**BACKGROUND:** The City has established revolving funds to cover City costs for abatement of property and dangerous building violations as a result of code enforcement activities as well as the generation of fines associated with administrative citations for property maintenance violations and fees and penalties associated with the Abandoned and Distressed Property Program. These costs, fines, fees and penalties are recovered through placement of special tax assessments upon the properties. The placement of special assessments and collection of revenue is done under Ordinance 2553, Property Appearance (Title 5, Chapter 22 of the Ontario Municipal Code), Chapter 9 of the Uniform Code for the Abatement of Dangerous Buildings and Ordinance 2920 for civil penalties for continued violations of the Ontario Municipal Code (Title 1, Chapter 2 of the Ontario Municipal Code) and fines associated with administrative citations (Title 1, Chapter 5 of the Ontario Municipal Code). The City and the County currently have a contractual agreement regarding implementation of special assessments; however, a resolution authorizing the placement of the specific assessments is required.

This assessment cycle, the Code Enforcement Department has billed \$606,157 in costs for the abatement of violations, the issuance of fines associated with administrative citations, and the issuance of registration fees and civil penalties associated with the Abandoned and Distressed Property Program on 888 parcels. Of this amount, \$244,841 has already been collected as a result in direct invoicing. Attached are itemized accountings of: 1) costs associated with inspection or abatement as shown in Exhibit A of the resolution; 2) civil penalties and/or fines for continued violations as shown in Exhibit B of the resolution; and 3) total amounts assessed per parcel as shown in Exhibit C of the resolution. The expenditure list, with any necessary corrections and adjustments, will be submitted to the County prior to August 2012 for placement on its 2012-2013 tax rolls. While the total amount of \$20,803 reflects funds expended in previous assessment cycles on matters that were being tracked at the City Attorney's office. Those matters have since been settled and the outstanding balances have been approved to be collected.

All affected property owners were given notice of the imposition of the special assessment via certified mail as provided in Ontario Municipal Code Section 1-4.05(a), and either have not requested an appeal or have exhausted the appellate procedure as provided in Ontario Municipal Code Section 1-4.05(b).

#### SUBJECT: CENTRACS ADVANCED TRAFFIC MANAGEMENT SYSTEM SOFTWARE

**RECOMMENDATION:** That the City Council approve the sole source purchase of the Centracs Advanced Traffic Management System Software from Econolite Control Products, Inc. of Anaheim, California, in the amount of \$145,000 including applicable sales tax and estimated shipping.

#### COUNCIL GOALS: <u>Develop Strategies and Take Actions to Minimize the Negative Impacts of</u> <u>the Global Financial Downturn on Ontario's Economy and the City's Fiscal Health</u> Invest in the City's Infrastructure (Water, Streets, Sewers, Parks, Storm Drains and Public Facilities)

**FISCAL IMPACT:** The Fiscal Year 2011-12 Capital Improvement Program includes appropriations of \$125,000 from Gas Tax funds for the Traffic Signal Management System Upgrade Project. The remaining funds required of \$20,000 are available from other Gas Tax funds appropriated for miscellaneous traffic signal upgrades.

**BACKGROUND:** This project will upgrade the City's outdated Econolite Aries and ICONS traffic signal system software with the latest Econolite Advanced Transportation Management System (ATMS) software known as Centracs. The Econolite Centracs software is capable of fully integrating the existing signal controllers and includes licensing for 200 intersections which should accommodate new installations during the next five to ten years. This purchase includes software, installation on City-owned equipment, on-site integration, training, testing and a one-year warranty.

This represents a large investment of City funds for equipment and technology that functions exceptionally well. The Centracs ATMS software maintains operational continuity with existing infrastructure and adheres to performance specifications unique to the traffic signal control equipment specified by the City.

**BACKGROUND:** On July 5, 2011 the City Council awarded Contract No's. GR0936A and GR0910A to Republic ITS for \$663,070 (including contingency) to replace 1,809 existing High Pressure Sodium (HPS) luminaires with Light Emitting Diode (LED) luminaires. There is approximately \$41,541 of unencumbered EECBG funds that could be used to replace additional existing HPS luminaries with LED luminaries. To take advantage of the additional funds, staff reviewed pricing with Republic ITS to replace an additional 114 lamps with LED units. Location maps are attached for reference as Exhibits "A" and "B". The original project is now complete and it is anticipated that change order work will be completed by April 2012, allowing for material delivery time.

**FISCAL IMPACT:** The cost associated with the transloading funding agreements was included in the appropriations for the City's 20% share towards the North Milliken Grade Separation Project construction cost which was budgeted in Fiscal Year 2009-10. The total estimated cost of the transloading funding agreements is \$250,000; the City's share is estimated to be \$50,000 which will be funded from Development Impact Fees.

**BACKGROUND:** The construction for North Milliken Grade Separation Project started in April 2011. Two industrial lead tracks servicing the surrounding businesses are proposed to be shut down starting January 23, 2012 to accommodate the grade separation project for four to six months. These tracks will be re-constructed as part of the grade separation project.

During the rail shut down period, the materials being delivered by these tracks will be transloaded and delivered via trucks to the impacted businesses. The two impacted businesses are Armorcast Product Company located on 500 S. Dupont Avenue and Cereal Food's facility located on 1051 S. Rockefeller Avenue. A location map is provided for reference.

**FISCAL IMPACT:** The City spends approximately \$43,000 annually for the containment, collection and disposal of hazardous materials. Funding for these services is included in the operating budgets for the Fire Department, Police Department, Community and Public Services Agency, and the Ontario Municipal Utilities Company. The recommended agreement would establish labor, materials and equipment billing rates for the initial term as well as optional extension periods; expenditures for any given year would vary dependent upon the number of cleanups and calls for service. Continuation of the agreement under the same fee structure would be contingent upon approval of the respective future fiscal years' budgets by the City Council. Contracting for goods and services on a multi-year basis allows the City to: limit yearly increases to the bid amount; eliminate man-hours in re-bidding the contract annually; and project estimated future costs. The amounts for future years will be based on City Council approved budget amounts and departmental requirements for service.

**BACKGROUND:** The Ontario Fire Department's HazMat Team routinely responds to calls for service involving the illegal or accidental release of hazardous waste or materials on public property. These incidents require immediate action to contain and dispose of the hazardous materials. Additionally, the City's public household chemical collection center and fleet maintenance program generate materials and waste products that must be disposed of in accordance with State and Federal regulations.

Accordingly, the Community and Public Services Agency and the Ontario Municipal Utilities Company contracts for hazardous waste removal at regular intervals. To address both sets of needs, the various departments utilized a coordinated contracting approach with primary responsibility for contract management residing with the Fire Department.

In November 2011, the City solicited proposals through the City's bid management system. Proposals were based on the type and level of activity historically experienced. Viable proposals were received from only two of the ten vendors showing interest.

Filter Recycling Services, Inc., located in Bloomington, was recommended by a review committee consisting of representatives from various City departments which utilize hazardous materials collection and disposal services. Filter Recycling Services, Inc. has been contracting with the City since July 2003, and the utilizing departments have been very satisfied with the level of services received. The selection committee also found their overall pricing to be favorable relative to the other response received.

The recommended action covers an initial one-year term and permits the extension of services for up to three additional one-year periods at the sole discretion of the City.

job creation and retention, and enhance transportation modal choices to promote environmental objectives.

The City's Downtown Core Catalyst Project is a multi-phased project consisting of the following eight individual projects: City Center Senior Apartments, Ontario Town Square C-1 Apartments, Grove/Holt Multi-Generational Apartments, Emporia Artist Colony, Ontario Downtown Plaza, Historic Bank of Italy Project, Civic Center Conservation Garden, and Downtown Civic Center Improvements. The general boundaries of the downtown core area are D Street to the north, Grove Avenue to the east, Emporia Street to the south, and Vine Avenue to the west.

Only thirteen communities were selected throughout California as catalyst communities. The City of Ontario as a designated Catalyst Community is eligible for a variety of resources and technical assistance, including but not limited to:

- A commitment on behalf of HCD and other State Departments to provide and facilitate technical resources in support of the Downtown Core Catalyst Project;
- Priority and/or bonus points for specified State funds; and
- Eligibility for \$500,000 in funds for capital improvements costs associated with the individual projects identified in the Downtown Core Catalyst Project. Applications for funds are due by January 31, 2012. Only designated Catalyst Communities are eligible for this funding.

City staff recommends the \$500,000 be applied towards the Downtown Civic Center Improvements Projects which includes the following activity:

- City Hall Annex Improvements, including the installation of equipment for the Emergency Operations Center.

If HCD approves the City's application, the City would satisfy all Award Letter conditions including the execution of the Memorandum of Understanding between HCD and the City of Ontario, and execution of a State of California Standard Agreement. A condition of the MOU is that the City will be required to submit reports in program years 1, 3, 5, and a final report regarding the results and outcomes of the Program.

The estimated approval time from the receipt of application to contract execution is approximately eight to ten weeks. Funds must be fully expended by June 30, 2016.

Vehicle Registration Fee Subvention Funds (AB2766 Subvention Funds) and local resources to expand access to and availability of CNG, along with the use of alternative fuel vehicles.

**BACKGROUND:** The US Army Corp of Engineers ("ACOE") recently initiated a Feasibility Study to evaluate habitat enhancement and recreation opportunities, as well as improvements to water quality, over a 300-acre area within Prado Basin. Detailed elements include identification of potential locations for habitat restoration along Mill Creek and Chino Creek, expansion of the recreational components of the Prado Regional Park, expansion of the regional trail system within the local communities as well as

the Coast to Crest inter-county trail system, and opportunities to create natural water quality treatment systems.

Because of the time involved in the development of the Feasibility Study, the City has been working with the ACOE on a smaller standalone project to provide regional water quality benefits/treatment. The Project is proposed on 47-acres of ACOE and private lands at the outfall of the Cucamonga Creek Flood Control Channel, on the north and south sides of Chino Corona Road in the City of Chino.

The Project contains the same three basic components as the larger plan: 1) the recreation plan; 2) the native habitat plan; and, 3) the water quality plan. The recreation plan proposes new active and passive recreation opportunities. Over three miles of new trails are proposed around the basins. These trails will provide vistas and wildlife viewing locations and interpretive signage. The Native Habitat Plan will create several habitat types that benefit the local wildlife, including endangered species. The Native Habitat Plan will create open water, wetlands, riparian, and oak woodlands that will support a wide range of wildlife. And finally, the water quality plan proposes to divert water from Cucamonga Creek into a series of basins that will remove pollutants through settlement, ultraviolet light treatment, and biological activity from the wetland vegetation

**ENVIRONMENTAL REVIEW:** The application is a project pursuant to the California Environmental Quality Act (Public Resources Code Section 21000 et seq.) ("CEQA") and an Expanded Initial Study has been prepared to determine possible environmental impacts. Because of the sensitive environmental in which the project is located, the Prado Basin, a great deal of time has been spent positioning the basins to minimize potentially significant impacts to the environment. In areas where the potential impacts can not be avoided, mitigation measures have been placed on the project to lessen the potential impacts to a level of less than significant. Because all the potential environmental impacts could be reduced to a level of less than significant, a Mitigated Negative Declaration was prepared pursuant to CEQA, the State CEQA Guidelines and the City of Ontario Local CEQA Guidelines.

The location of the project is such that reviews and/or permits are required from several agencies. These include the ACOE, City of Chino, San Bernardino County Flood Control District, San Bernardino County Parks Department, Santa Ana Regional Water Quality Control Board, California Department of Fish & Game, and US Fish & Wildlife Service. Additionally, the project is considered a "project of regional significance" under CEQA. As a result, the IS/MND was sent to the State Office of Planning and Research for a 30-day public comment period beginning December 22, 2008, and extending through January 20, 2009. During the public comment period, comments were received from several individuals or organizations - Dan Silver, Endangered Habitats League; Southern California Edison; State Water Resources Control Board; California Department of Fish & Game; Dr. Jack Bath; and, the City of Chino. Staff and the City's consultant have reviewed the comments received and provided responses to the comments (see attached). The response letters were sent to the commenters prior to the hearing. Staff does not believe the content of the letters identifies impacts not previously considered in the IS/MND. Additionally, given the length of time that has passed since distribution of the IS/MND, the Lead Agency has reviewed the document pursuant to CEQA Guidelines Section 15073.5, Recirculation of a Negative Declaration Prior to Adoption. The Lead Agency is required to recirculate a negative declaration when substantial revisions occur to the document. Substantial revisions include:

• New avoidable significant impacts are identified and mitigation measures must be added in order to reduce the impact to less than significant.

• New measures or revisions are required because proposed measures will no longer reduce potential effects to less than significant.

Upon review of the IS/MND, the Lead Agency has determined that substantial revisions are not required to the document and therefore recirculation is not required.

As previously mentioned, the IS/MND contains mitigation measures to reduce the potential environmental impacts to less than significant levels. To ensure that the mitigation measures are implemented, a Mitigation Monitoring and Reporting Program has been prepared for the Project pursuant to CEQA Guidelines Section 15097. The Mitigation Monitoring and Reporting Program specifies responsible agencies/departments, monitoring frequency, timing and method of verification and possible sanctions for non-compliance with mitigation measures.

Staff recommends that the City Council approve the conceptual plan, the Mitigated Negative Declaration and the Mitigation Monitoring and Reporting Program for the Mill Creek Wetlands Recreation and Restoration Project through adoption of the attached Resolution.
