


FISCAL IMPACT: None. Pursuant to the NMC Construction Agreement, the acquisition cost of \$107,642 is being paid for by the NMC Builders LLC in association with the Edison Avenue and Archibald Avenue street improvements and will be eligible for reimbursement from the Development Impact Fee (DIF) program.


BACKGROUND: NMC Builders LLC, as required per the NMC Construction Agreement, is currently constructing the Edison Avenue and Archibald Avenue improvements. The sections of Edison Avenue at the Cucamonga Creek Channel and Archibald Avenue at Lower Deer Creek are classified as an 8-lane principal arterial and a 6-lane principal arterial in The Ontario Plan, respectively. To accommodate the improvements on Edison and Archibald Avenues, it is necessary to acquire the right of way from SBCFCD as shown on the attached Exhibits 1, 2 and 3. The Right of Way Purchase Agreement is required by SBCFCD in order to convey the required right of way to the City. The proposed agreement has been reviewed and approved by the City Attorney.

RECOMMENDATION: That the City Council approve and authorize the City Manager to execute a Facilities Relocation Agreement (on file with the Records Management Department) with Southern California Edison (SCE) for the relocation of SCE facilities along Edison Avenue from the Cucamonga Creek Channel to Turner Avenue.

COUNCIL GOALS: <u>Regain Local Control of the Ontario International Airport</u> <u>Pursue City's Goals and Objectives by Working with Other Governmental Agencies</u> <u>Ensure the Development of a Well Planned, Balanced, and Self-Sustaining Community in the New</u> <u>Model Colony</u>

FISCAL IMPACT: None. Pursuant to the NMC Construction Agreement, the cost of the SCE facilities relocation (estimated to be \$1,101,000) is being paid for by NMC Builders LLC in association with the Edison Avenue street improvements and will be eligible for reimbursement from the Development Impact Fee (DIF) program.

BACKGROUND: As part of the Edison Avenue Improvement Project in the New Model Colony, the City has requested that SCE relocate the portion of their existing facilities that interfere with the City's project. Currently, SCE's utility poles are in conflict with the construction of the recycled water and street widening improvements on Edison Avenue and will have to be relocated from the north side of the street to the south side, behind the ultimate curb and gutter location.

The Facilities Relocation Agreement is required by SCE and outlines the scope of work associated with SCE's relocation project and has been reviewed and approved as to form by the City Attorney.

RECOMMENDATION: That the City Council approve the plans and specifications and award a construction contract (on file in the Records Management Department) to American Asphalt South, Inc. of Fontana, California for the City of Ontario FY 2014-15 / FY2015-16 Collector/Arterial, Local Street Maintenance Slurry Seal and CDBG Pavement and Alley Pavement Management Rehabilitation in the bid amount of \$1,837,193 plus a twenty (20%) percent contingency of \$367,439 for a total authorized expenditure of \$2,204,632; and authorize the City Manager to execute said contract and related documents, and file a notice of completion at the conclusion of all construction activities for the project.

COUNCIL GOALS: <u>Regain Local Control of the Ontario International Airport</u> <u>Focus Resources in Ontario's Commercial and Residential Neighborhoods</u> <u>Invest in the City's Infrastructure (Water, Streets, Sewers, Parks, Storm Drains and Public Facilities)</u>

FISCAL IMPACT: The FY 2014-15 Budget includes appropriations of \$650,000 from Measure "I" funds, \$192,500 from CDBG funds, and \$312,000 from Gas Tax funds for a total of \$1,154,500. The FY 2015-16 Budget contains \$400,000 from Gas Tax funds, \$650,000 from Measure "I" funds and \$400,000 from CDBG funds for a combined two (2) Fiscal Year appropriation of \$2,604,500 for this project. The total recommended expenditure authorization of \$2,204,632 consists of the bid amount of \$1,837,193 plus a 20% contingency of \$367,439.


The total bid amounts shown above provide for alternative awards allowing staff to choose between two different slurry materials. Alternate Bid Schedule "B" includes RPMSS and was chosen due to the higher quality and longer life cycle combined with favorable bid prices. American Asphalt South, Inc. of Fontana, CA. submitted the lowest-responsible bid; and is recommended at a project cost of \$1,837,193 (Base Bid of \$905,450 plus Option 1-Schedule B of \$931,743). American Asphalt South, Inc. has performed similar work for the City of Ontario in a satisfactory manner.



FISCAL IMPACT: The Fiscal Year 2014-15 Budget includes appropriations of \$2,055,955 from Measure I funds, \$521,000 from Gas Tax funds, and \$433,170 from Community Development Block Grant for a total budget of \$3,010,125 related to the Pavement Rehabilitation and CDBG Funded Alley Reconstruction Project. All American Asphalt submitted the lowest bid of \$2,281,410. A 15% contingency is recommended due to the need to extend project limits and the potential for additional repair work.

BACKGROUND: The scope of services for the FY 2014-15 Pavement Rehabilitation and CDBG Funded Alley Reconstruction Project includes cold planing, removal and replacement of damaged pavement, construction of Asphalt Rubber Hot Mix (ARHM) overlay, construction of ADA compliant access ramps, and placement of traffic striping, pavement markings, and raised markers.

The project locations include: rehabilitation of Baker Street from Riverside Drive to Fairfield Court (Project No. ST1401); Shelby Street from Inland Empire Boulevard to Haven Avenue (Project No. ST1402); Parco Avenue from Francis Street to Locust Street (Project No. ST1404); "D" Street from

SUBJECT: ACCEPT A GRANT AWARD FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY / U.S. DEPARTMENT OF HOMELAND SECURITY (FEMA/DHS)

RECOMMENDATION: That the City Council accept a grant award from the Federal Emergency Management Agency / U.S. Department of Homeland Security (FEMA/DHS) in the amount of \$90,350 for the purchase of firefighter personal escape and rescue system equipment.

COUNCIL GOALS: <u>Regain Local Control of the Ontario International Airport</u> <u>Maintain the Current High Level of Public Safety</u> <u>Pursue City's Goals and Objectives by Working with Other Governmental Agencies</u>

FISCAL IMPACT: The estimated cost to purchase personal escape and rescue system equipment is \$90,350. The Federal share is 90%, or \$82,137, of the approved amount and FEMA/DHS requires a 10% local match of \$8,213. If approved, grant revenue and associated expenditure appropriations will be included in the next quarterly budget report to the City Council. If the City obtains favorable bid results in the procurement of the 130 firefighter personal escape and rescue systems (PERS), any remaining grant funds are recommended to be spent on similar fire operations and safety equipment pursuant to the granting agency's program guidance. The ongoing maintenance and replacement of this equipment will be incorporated into the Fire Department's existing annual maintenance and equipment replacement programs.

BACKGROUND: In December 2014, the Ontario Fire Department applied for funds offered through the FY 2014 FEMA/DHS Assistance to Firefighters Grant (AFG) Program to purchase 130 firefighter personal escape and rescue systems. Notice of a successful award and grant guidelines were received on June 19, 2015.

Firefighters depend on personal escape and rescue systems in order to safely remove themselves from an uncontrolled emergency situation such as a partial collapse, multi-story structure fire escape scenario, and other dangerous environments. Current department self-escape rope systems lack consistency and

vary considerably between apparatus, which impacts the ability to train and test efficiently. These new deployable rope systems are considered industry best practice support equipment and are National Fire Protection Association (NFPA) compliant.

Contracting for the multi-year period will allow the City to limit the potential for yearly increases to the bid amounts, avoid the costs of re-bidding the contract annually, and provide service continuity and project future costs.

BACKGROUND: The Maintenance Service Agreement scope provides regularly scheduled fire sprinkler and kitchen suppression system maintenance services. The City's facilities inventory includes 18 sites for fire sprinkler and kitchen suppression system services. The buildings range in use from office/professional to community recreation to public safety.

All proposals received were reviewed and evaluated for factors advantageous to the City including fee proposal, Environmental Laboratory Accreditation Program and other certifications, proficiency testing reports, qualifications and experience, equipment, location, ability to perform all of the required analyses, and quality/responsiveness of the proposal. Of the six proposals, Babcock Laboratories, Inc. was best able to comprehensively provide the analytical services needed by the City. Babcock Laboratories, Inc. is also qualified to perform the City's UCMR3 monitoring in house.

The City must ensure that all regulatory monitoring and reporting is performed correctly, timely, and in a manner that meets all State and Federal requirements. The U.S. Environmental Protection Agency and the State Water Resources Control Board, Division of Drinking Water require the City to monitor the quality of water at each source and at selected locations throughout the distribution system in accordance with the Federal Clean Water Act and Title 22 of the California Code of Regulations.

Under the Joint Wastewater Discharge Permit issued by the Inland Empire Utilities Agency and the County Sanitation Districts of Los Angeles County for discharge to the Non-Reclaimable Wastewater System, the City must monitor the quality of wastewater discharged from the John Galvin Ion Exchange Treatment Plant. Additionally, wastewater flow monitoring, sample collection, and analyses are needed to monitor industrial user compliance with 40 Code of Federal Regulations Parts 136-424, and local limits.

The estimated General Fund portion is \$88,000 for FY 2015-16, with a similar proportionate impact projected for the following fiscal year. Appropriations for the first year of the agreement are included in the Adopted Fiscal Year 2015-16 Operating Budget.

BACKGROUND: The current Memorandum of Understanding (MOU) between the City and AFSCME began on July 1, 2013 and expires June 30, 2016. COUNCIL GOALS: <u>Regain Local Control of the Ontario International Airport</u> <u>Operate in a Businesslike Manner</u>

FISCAL IMPACT: The estimated additional annual cost of the compensation changes across all funds during the two-year period is \$293,000 for FY 2015-16 and \$457,000 for FY 2016-17. The estimated General Fund portion is \$210,000 for FY 2015-16, with a similar proportionate impact projected for the following fiscal year. Appropriations for the first year of the agreement are included in the Adopted Fiscal Year 2015-16 Operating Budget.

BACKGROUND: Employees in the Part-Time, Confidential, Department Head, and Executive Management groups are not formally organized and, as such, are not represented by any employee group, union, or association. For unrepresented groups, the profile for each group describes the compensation, benefits, and other relevant employment provisions as approved by the City Council. The proposed amendments to the Profiles address a modification of salary and employees' share of retirement contributions.

The City recognizes the importance of maintaining its fiscally conservative approach. In an effort to continue to address future retirement costs while maintaining a competitive employee benefit package, it

is recommended that the employees' share of retirement contributions be increased consistent with the agreements made with two of the three represented miscellaneous bargaining units. As specified in the current Compensation and Benefits Profiles for Confidential, Department Head, and Executive Management groups, employees were previously scheduled to contribute 6.25% toward their retirement costs by July 2015. Under the proposed amendments, employees' contribution toward their retirement costs will increase to 7% in July 2016 and to 8% in January 2017. In addition, to assist the City in its ability to recruit and retain a highly qualified workforce, employees in the Part-Time, Confidential, Department Head, and Executive Management groups will receive a general salary increase of 2% in July 2015 in addition to the 3.5% general salary increase that had already been approved in the current Compensation and Benefits Profiles. Employees will also receive general salary increases of 1.75% in July 2016 and 3% in January 2017, for a net change in FY 2016-17 of 3% after accounting for the employee's share of employee retirement contributions.

As required by Ontario Municipal Code Section 2-3.106, the City Council must set the salary for the City Manager by resolution, and such salary is consistent with the salary table contained in the proposed resolution. Additionally, California Government Code Section 36506 requires the City Council to set the salaries for appointive positions in the Executive Management group by resolution, and such salaries are consistent with the salary range table contained in the Executive Management Compensation and Benefits Profile.

These amendments will provide the City of Ontario with added economic certainty for budget forecasting in upcoming years while reflecting the positive partnership between the unrepresented group employees and the City of Ontario.

- 1. Effective July 12, 2015, base salary ranges shall increase by 2% in addition to the 3.5% previously approved by the City Council.
- 2. Effective July 10, 2016, base salary ranges shall increase by 1.75%.
- 3. Effective January 8, 2017, base salary ranges shall increase by 3%.

WHEREAS, the employee contribution toward retirement costs recommended by the City Manager for the positions of Fire Chief and Police Chief reflect the same increases for all employees in Executive Management positions and are contained in the Executive Management Compensation and Benefits Profile for the City which was approved on July 7, 2015, as follows:

- 1. Effective July 10, 2016, the employee contribution toward retirement costs shall increase to 7%.
- 2. Effective January 8, 2017, the employee contribution toward retirement costs shall increase to 8%.

WHEREAS, the City Council has reviewed the salary range table for the positions of Fire Chief and Police Chief reflecting the proposed base salary range increases, attached hereto as Exhibit "A."

Total compensation paid toward supplies shall not exceed the appropriation levels for maintenance, repairs and projects as contained in the approved budgets for each respective fiscal year.

BACKGROUND: The City routinely purchases concrete, asphalt and aggregate materials from suppliers on an as needed basis for on-going maintenance and repairs, as well as capital projects. Generally, these materials are used for the annual street overly program, daily pot hole repairs, sidewalk, and utility trench repairs, and any miscellaneous projects and requests on public streets and right of ways throughout the City.

Government Code Section 37422 states that such resolution shall fix a time for hearing protests to the property conveyance, provide for publication of notice of the hearing, fix the time when the City will take final action regarding the property conveyance, and contain an accurate description of the property to be conveyed.

The City is proposing to convey property located at 616 East Sunkist Street by entering into a Disposition and Development Agreement ("DDA") with MGH Ontario, LLC, for purposes of economic development on July 21, 2015. WHEREAS, the City wishes to declare its intent to dispose of and convey the Property pursuant to the terms of the DDA, fix a time for the hearing of any protests to the disposition, provide for publication of the notice of said hearing, and fix the time for final action on the disposition of the Property and approval of the DDA.

WHEREAS, City staff have determined that there is no possibility that the proposed sale of the Property will have a significant adverse effect on the environment and that the adoption of this Resolution is therefore exempt from the requirements of the California Environmental Quality Act ("CEQA") pursuant to Section 15061(b)(3) of the CEQA guidelines.

<u>SECTION 1</u>. <u>Incorporation of Recitals</u>. The foregoing recitals are true and correct and are incorporated herein and made an operative part of this Resolution.

<u>SECTION 2</u>. <u>Findings</u>. The City Council of the City hereby finds and determines that public convenience and necessity require the sale of the Property. The factors demonstrating that the public convenience and necessity require the sale of the Property include, but are not limited to the following: the Property will be utilized by MGH Ontario, LLC as an industrial reuse of the former Sunkist Fruit Packing Facility for economic development purposes, which will create jobs within the City, alleviate conditions of economic and physical blight in the City, and create an increase in property taxes, all of which benefit the health, safety and welfare of the City.

<u>SECTION 3.</u> <u>Declaration of Intent to Sell; Fixing of Hearing</u>. The City Council of the City hereby declares its intent to sell the Property pursuant to the DDA and fixes July 21, 2015 at 6:00 P.M. or as soon thereafter that the matter can be heard at the City of Ontario, City Council Chambers, located at 303 East "B" Street, Ontario, California 91764 as the date, time and location for hearing any protests to the proposed sale of the Property, approval of the DDA, and as the final action date.

<u>SECTION 4</u>. <u>Publication and Posting</u>. In compliance with California Government Code Section 37423, the City Council of the City hereby directs City staff to publish this resolution at least once in a daily newspaper prior to July 21, 2015 and to post this Resolution for not less than ten (10) days in at least three (3) conspicuous places upon the Property prior to July 21, 2015.

RECOMMENDATION: That the City Council hold a public hearing to consider approval of owner's permits for the provision of taxicab services within the City of Ontario to Network Paratransit Systems, Inc. dba Bell Cab Company, San Bernardino, California, Rykal LLC dba Yellow Cab Company, Thousand Palms, California, and Express Transportation Systems Inc. dba Checker Cab & Inland Empire Cab, Riverside, California; and authorize the City Manager to execute five-year service agreements with these companies.

COUNCIL GOALS: <u>Regain Local Control of the Ontario International Airport</u> <u>Operate in a Businesslike Manner</u>

FISCAL IMPACT: None. The cost of inspections and permitting is reimbursed through the collection of vehicle inspection fees paid by the taxicab service providers.

BACKGROUND: Title 4, Chapter 5, of the Ontario Municipal Code (OMC) establishes comprehensive requirements and regulations concerning the provision of automobiles for hire and taxicab services within the City of Ontario. Currently, Network Paratransit Systems, Inc. dba Bell Cab Company, and Rykal LLC dba Yellow Cab Company are authorized to operate within the city limits (including Ontario International Airport, as approved by Los Angeles World Airports).

OMC Section 4-5.05 provides that any person desiring to renew an existing permit should submit a letter to the City Council between June 1 and June 30, or within thirty days of the expiration of their permit. That section also provides that any person who desires to obtain a new permit should submit a letter to the City Council between June 1 and June 30.

Network Paratransit Systems, Inc. dba Bell Cab Company, submitted such a letter seeking to renew its existing permit, dated June 24, 2015. Rykal, LLC dba Yellow Cab Company, also submitted such a

letter, dated June 24, 2015. Express Transportation Systems Inc. dba Checker Cab & Inland Empire Cab submitted a letter seeking to obtain a new permit, dated June 25, 2015.

Staff reviewed the provisions of OMC Section 4-5-05(b) related to making a determination of the public convenience or necessity requiring an additional permit. The guiding factors include:

- the transportation needs of residents and visitors of the City;
- the number of taxicabs and limousines, and other automobiles for hire already operational in the City;
- whether existing transportation services are adequate to meet the public need;
- the probable effect of additional taxicabs or automobiles for hire on local traffic conditions;
- the effect of increased competition on the revenues of existing permittees and on the wages, compensation, hours, and conditions of service of existing licensed drivers; and
- other relevant factors.

Based upon the review, staff recommends the issuance of five-year owner's permits and the related service agreements for Bell Cab Company, Rykal LLC dba Yellow Cab Company, and Express Transportation Systems, Inc. dba Checker Cab & AA Inland Empire Cab. During the term of the agreements, staff will continue to monitor the taxicab operators based upon performance criteria in the areas of customer response times, fleet size, driver standards, vehicle and safety standards, and dispatching system standards.

On behalf of Express Transportation Systems, DBA Checker Cab & AA Inland Empire Cab, I am writing to request that the City of Ontario make a finding of Public Convenience and Necessity determination for the issuance of an additional permit to operate a taxi cab service within the City. Per Title 4 Chapter 5 Section 6 of the Ontario Municipal Code, a letter must be submitted to the City Clerk requesting that the City Council determine that the public convenience and necessity require that a permit be issued for a new franchisee. Please consider this correspondence to be an official request.

There are six factors that the City Council must consider in determining that public convenience and necessity requires an additional permit be issued. First and foremost amongst them ranks the transportation needs of residents and visitors to the City of Ontario. In a recent survey conducted of your hotels, restaurants and other businesses commonly used by both tourist, business visitors and residents alike in the City of Ontario, the majority responded that they are dissatisfied with the level of service provided by the City's two existing franchised taxi cab operators. We believe this is due in part to the reduction in passenger traffic at Ontario International Airport and a reallocation of resources outside the City by the existing taxi cab providers. Express Transportation Systems has NO interest in serving ONT and understands that process is managed by LAWA. Nonetheless, reduced passenger traffic at the airport has had a cascading effect that undermined service provision to residents and business interests throughout the City. Therefore, Express Transportation Systems seeks to provide transportation services that again meet the stated needs of the Ontario community, both commercial and residential.

The second factor to consider is the number of taxi cabs and limousines, and other automobiles for hire, currently licensed in the city. Due to reduced flight volumes at ONT, currently licensed taxi cab and transportation providers have drastically reduced the available fleet of service vehicles in the City of Ontario. This is confirmed by our recent survey of hotels and restaurants within the City of Ontario over the past six months. Therefore, Express Transportation Systems seeks to fill the void that currently exists.

The third factor to consider is whether existing transportation services are adequate to meet the public need. As discussed previously, objective survey results from numerous and prominent business leaders throughout the City of Ontario have demonstrated there is a void of reliable service provision resulting in inadequate services to meet public need. The results of the survey were significant and demand swift action. Express Transportation Systems has a proven track record throughout the Inland Empire and southern California, as well as the resources and the desire to step in and fill the current void, returning transportation services to a level that meets public demand and need.

The fourth factor to consider is the probable impact of additional taxi cabs or automobiles for hire on local traffic conditions. Express Transportation Services operates in many congested and impacted areas, making our service team uniquely cognizant of such concerns. The dramatic reduction in taxi service over the past several years has created a valid and tangible need, and Express Transportation Services is offering to adequately re-equip the City of Ontario with a fleet of taxi options that adequately meets the public's need, returning services and vehicles to pre-approved levels or necessity.

The fifth factor to consider is the effect of increased competition on the revenue of existing permittees and on the wages, compensation, hours and conditions of service of existing drivers. As mentioned previously, Ontario has seen a dramatic reduction from the approved level of taxi and transportation services due to reduced flight volume. Current licensees have focused their attention on providing service to ONT while Express Transportation Services has no interest in dedicating fleet services to the airport. The entirety of the fleet will be focused on serving the hotel, business and residential populations of Ontario. With a focus, distinct from current providers, targeting a market that has seen a dramatic reduction of dedicated service fleet over the last few years, Express Transportation Services believes there will be little adverse impact to existing permittees, wages, compensation, hours and/or conditions of service for existing drivers.

The final factor to consider is the distinguished track record that Express Transportation Systems brings to the City of Ontario. Currently operating in Los Angeles, Riverside and San Bernardino Counties, Express is a premier operator with taxi cab drivers who are all held to an exceptionally high standard, including being cross-trained in non-emergency medical transportation, which requires three (3) certifications, including CPR.

In light of these six factors, Express Transportation Systems believes it can be a valuable asset to the City of Ontario and its residents and that an important public convenience and necessity would be met in issuing a permit for the expanded provision of taxi services. Associated costs related to local signage and marketing materials will be covered within the City Council approved operating budget for the museum for this fiscal year. Large signage and monument type signage, once designed, will be included in future budget requests to the City Council, as needed.

BACKGROUND: The Museum of History and Art, Ontario Board of Trustees held several workshops to discuss arts and culture initiatives in the City of Ontario, they also obtained input from outside stakeholders. A major focus in the workshops was the stated desire to rebrand the Museum of History and Art, Ontario to coincide with citywide branding and destination marketing efforts.

The recommended name change to "Ontario Museum of History and Art" emphasizes the location of the museum as being in the City of Ontario and thereby calls attention to the arts and cultural offerings in the City. At a special meeting on June 15, 2015, the Museum Board of Trustees unanimously recommended that the City Council amend Section 2-9.02 and 2-9.03 of the Ontario Municipal Code to reflect the recommended new name of the City's public museum.



A RESOLUTION OF THE MUSEUM OF HISTORY AND ART, ONTARIO BOARD OF TRUSTEES OF THE CITY OF ONTARIO, CALIFORNIA, RECOMMENDING THE CITY COUNCIL AMEND CHAPTER 9 OF TITLE 2 OF THE ONTARIO MUNICIPAL CODE RELATING TO THE PUBLIC MUSEUM.

WHEREAS, the Museum of History and Art, Ontario Board of Trustees ("Board of Trustees") has held workshops to discuss arts and culture initiatives in the City of Ontario ("City") with Downtown arts and culture stakeholders; and

WHEREAS, the Board of Trustees desires to rebrand the Museum of History and Art, Ontario to coincide with citywide branding and destination marketing; and

WHEREAS, the Board of Trustees recommends to the City Council to amend Chapter 9 of Title 2 of the Ontario Municipal Code relating to the Public Museum to change the name of the public museum to "Ontario Museum of History and Art."

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED, AND RESOLVED, by the Museum of History and Art, Ontario Board of Trustees of the City of Ontario as follows:

<u>SECTION 1.</u> Findings. The foregoing recitals are true and correct, and are incorporated herein and made an operative part of this Resolution.

<u>SECTION 2.</u> Chapter 9 of Title 2 of the Ontario Municipal Code is hereby amended, in its entirety, to read as follows:

Sec. 2-9.03. Name.

The public museum shall be given the name of "Ontario Museum of History and Art."

<u>SECTION 3.</u> Severability. If any provision of this Resolution is held invalid, the remainder of this Resolution shall not be affected by such invalidity, and the provisions of this Resolution are severable.

<u>SECTION 4.</u> Effective Date. This Resolution shall become effective immediately upon its adoption.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, AMENDING CHAPTER 9 OF TITLE 2 OF THE ONTARIO MUNICIPAL CODE TO APPROVE CHANGING THE NAME OF THE PUBLIC MUSEUM TO "ONTARIO MUSEUM OF HISTORY AND ART."

WHEREAS, the Museum of History and Art, Ontario Board of Trustees ("Board of Trustees") has held workshops to discuss arts and culture initiatives in the City of Ontario ("City") with Downtown arts and culture stakeholders; and

WHEREAS, the Board of Trustees desires to rebrand the Museum of History and Art, Ontario to coincide with citywide branding and destination marketing; and

WHEREAS, at a Special Meeting on June 15, 2015, the Museum Board of Trustees unanimously recommended that the City Council amend Chapter 9 of Title 2 of the Ontario Municipal Code to reflect changing the name of the public museum; and

WHEREAS, on July 7, 2015, the City Council held a public hearing regarding the amendment to Chapter 9 of Title 2 of the Ontario Municipal Code to reflect the name change of the public museum.

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED, AND ORDAINED by the City Council of the City of Ontario, as follows:

<u>SECTION 1.</u> Findings. The foregoing recitals are true and correct, and are incorporated herein and made an operative part of this Ordinance.

<u>SECTION 2.</u> Chapter 9 of Title 2 of the Ontario Municipal Code is hereby amended, to read as follows:

<u>SECTION 3.</u> Severability. If any provision of this Ordinance is held invalid, the remainder of this Ordinance shall not be affected by such invalidity, and the provisions of this Ordinance are severable.

<u>SECTION 4.</u> Effective Date. This updated amendment to the Ordinance shall become effective thirty (30) days following its adoption.

<u>SECTION 5.</u> The Mayor shall sign this Ordinance and the City Clerk shall certify as to the adoption and shall cause a summary thereof to be published at least once, in a newspaper of general circulation in the City of Ontario, California within fifteen (15) days of the adoption. The City Clerk shall post a certified copy of this ordinance, including the vote for and against the same, in the Office of the City Clerk, in accordance with Government Code Section 36933.
