City Attorney Brown reported that a second item was added to the Closed Session Agenda, for which Council Member Wapner was absent, but there was no reportable action taken on either item.

PUBLIC COMMENT

Dorene Hopkins said there were no improvements in the downtown area, opposed illegal immigrants, alleged people were avoiding the library, and commented on the bad weather in the midwest and on the east coast.

City Council approved a cooperative agreement with Caltrans for the City to commence the Project Approval and Environmental Documentation (PA&ED) phase of the I-10 and Grove Avenue Interchange and Grove Avenue Corridor Project; and authorized the City Manager to execute said agreement and all future amendments.

4. A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, IN OPPOSITION TO THE STATE ADMINISTRATION'S PROPOSAL TO ABOLISH REDEVELOPMENT AGENCIES IN CALIFORNIA

City Council adopted a Resolution opposing the State Administration's proposal to permanently abolish California's more than 400 local redevelopment agencies.

City Council received public comment on the proposed spending plan for Fiscal Year 2010-11 Supplemental Law Enforcement Services Fund (SLESF)/Citizen's Option for Public Safety (COPS) Grant; and approved the proposed spending plan.

City Council and the Ontario Redevelopment Agency Board considered and adopted Resolutions approving a Disposition and Development Agreement between the Ontario Redevelopment Agency and Sea Partners, a California limited liability company; and authorized the City Manager and Executive Director to execute the Disposition and Development Agreement and other related documents necessary to carry out disposition of the property.

Motion: Moved by Mayor pro Tem Dorst-Porada, seconded by Council Member Bowman, and unanimously carried to adopt said Resolutions Nos. 2011-004 and ORA-813.

APPOINTMENT TO MUSEUM OF HISTORY AND ART BOARD OF TRUSTEES

Council Member Wapner introduced Rick Caughman as his appointment to the Board of Directors for the Museum of History and Art.

COUNCIL/ STAFF COMMENT

Mayor pro Tem Dorst-Porada thanked participants who walked with her on Sunday down Euclid Avenue and said everyone is welcome to join them. She announced the Artists' Model Colony *Art Walk* at 6:00 p.m., on February 19th. Ms. Dorst-Porada expressed concern about skilled nursing facilities in the City of Ontario. She explained that many times the facilities have inadequate medical personnel to evaluate emergency situations, so they call on the City's paramedics to go out to the facilities and make determinations. She recommended a review of Upland's Program to address this issue, for possible application in Ontario. There were no objections to her suggestion.

Council Member Wapner supported the Resolution adopted this evening in opposition to the Governor's attempt to rid communities of redevelopment agencies and suggested the City Manager work on an approach and plan for addressing this item if it is approved. Council Members concurred with him. Mr. Wapner also commented on the current vacancy on the Vector Control Board saying most other cities have an elected representative and suggested that a member of Council be appointed to fill the vacancy.

Mayor Leon said he will be happy to do so and City Manager Hughes said he will add this to a future agenda.

Council Member Bowman indicated he agrees with suggestions put forth by Council Member Wapner with respect to redevelopment agencies noting the whole City will suffer if it is approved; he added that this is one-time money for the state but will impact local redevelopment agency work to remove blight in the community over many years. Mr. Bowman added that he, Mayor Leon and Council Member Wapner participated when ProLogis pulled the switch turning on their solar power installation on Francis Street. He reminded everyone to celebrate Valentine's Day on February 14th.

Council Member Mautz agreed that the redevelopment agency issue cannot be over stressed and suggested citizens make phone calls to State legislators.

Mayor Leon said the ProLogis event was an amazing display of solar energy where the panels covered an area akin to 60 football fields. He commented on the consistent application of policies and projects by this Council, noting there are many amenities in Ontario where they hope to continue the progress. The Mayor then commented on the California Sports Hall of Fame and the induction ceremony that will be held at 6:00 p.m., on February 27th at the Ontario Convention Center. He said there will be 5 inductees

this year and tickets are available on their web site. Mayor Leon said he would like to see this event return to Ontario each year.

Council Member Wapner thanked the Mayor for his involvement saying he appreciates all he has done to bring the California Sports Hall of Fame to Ontario noting it is a great way to meet sports personalities.

The meetings of the joint agencies adjourned at 7:05 p.m., and Mayor Leon announced the next regular meetings will be held on February 15th.
