## COUNCIL MATTERS

Mayor Leon stated that City Council made note of the questions and comments from the residents and added that comprehensive answers will be provided to residents. Mayor Leon stated the importance of moving forward in addressing concerns with the project as opposed to focusing on actions that took place in the past.

Council Member Bowman asked that City Manager Boling clarify the staff's recommendations.

City Manager Boling stated that it was the staff recommendations that the City engage an environmental engineer to review and analyze CEQA mitigation measures, compliances by SCE; that the City engage a utilities consultant to review and analyze easements for compliance and any title issues; and that City staff and the City Attorney's Office continue pursuing the Petition for Modification to Stay and the Petition for Modification to Order the Undergrounding.

Council Member Bowman expressed support for the recommendations and added that the City Council should seek support from legislative representatives at higher levels of government.

Council Member Dorst-Porada also added that there should be a single source or accessible location where residents can get information and updates.

**MOTION:** Moved by Council Member Bowman, seconded by Mayor pro Tem Wapner and unanimously carried to approve staff recommendations as amended.
