#### **JOINT MEETINGS**

#### **PUBLIC COMMENTS**

Peggi Hazlett introduced Chamber Board Member Loren Brewster, Operations Manager for Toyota Motor Sales. She also offered congratulations to Chief Derek Williams.

Loren Brewster commented on Chamber of Commerce programs and noted upcoming events including Good Morning Ontario on April 4th at 7:30 a.m.; and the 58th Annual Police Recognition Luncheon on May 8, 2018.

Jason Anderson commended the City Manager and City Council on the consideration of Derek Williams for Police Chief. He commented on their long term friendship and congratulated Chief Williams on this appointment.

Victor Vasquez commented on a traffic stop that took place in August 2017 in which his personal property was lost. He indicated that he ultimately received a settlement for his loss, but criticized Ontario police officers for their role in this situation.

Michael Harris indicated that he moved to Ontario from Washington, D.C. and circumstances left him homeless. He expressed concern with the treatment of the homeless community by Ontario police and indicated that he will become the face of the homeless through his participation in a class action lawsuit.

City Council authorized the City Manager to execute a four year agreement with AdminSure, Inc. of Ontario, CA, for Workers' Compensation Third Party Claims Administration Services including medical bill review and utilization review services, in the amount of \$290,400 from May 1, 2018 through April 30, 2019, and not to exceed a 3% escalation each subsequent year.

City Council approved and authorized the City Manager to execute a four-year Memorandum of Understanding regarding wages, hours and other terms and conditions of employment between the City of Ontario and the Ontario Police Management Group (OPMG); and authorized the City Manager to make any non-substantive changes which may be necessary to implement the agreement; and adopted resolutions modifying the Employer Paid Member Contributions (EPMC) to the California Public Employees Retirement System (CalPERS)

5. PURCHASE AND IMPLEMENTATION OF A NEW UTILITY BILLING SOFTWARE SOLUTION USING CIS INFINITY FROM ADVANCED UTILITY SYSTEMS/ADVANCED UTILITY SYSTEMS

City Council authorized the City Manager to execute a multi-year agreement with Advanced Utility Systems, a subsidiary of Harris Computer Systems of Ottawa, Ontario, Canada for utility billing software, in the amount of \$2,861,813 and authorized a 25% project contingency of \$715,453 for a combined project total amount not to exceed \$3,577,266.

6. A CONSTRUCTION CONTRACT FOR THE QVC WAY STREET IMPROVEMENT PROJECT/HILLCREST CONTRACTING, INC.

City Council approved the plans and specifications and awarded a construction contract to Hillcrest Contracting, Inc. of Corona, California for the QVC Way Street Improvement Project (ST1718) in the bid amount of \$443,339 plus a 10% contingency of \$44,334 for a total authorized amount of \$487,673; and authorized the City Manager to execute said contract and related documents and file a Notice of Completion at the conclusion of the construction activities.

7. A PROFESSIONAL SERVICES AGREEMENT FOR FINANCIAL AUDIT SERVICES/LANCE, SOLL & LUNGHARD

City Council authorized the City Manager to execute a three year professional services agreement with the accounting firm of Lance, Soll & Lunghard, LLP, of Brea, California, in the amount of \$296,360 to perform annual auditing services for the City of Ontario, the Ontario Housing Authority, and the Successor Agency of the former Redevelopment Agency; and authorized extension of the agreement for up to two additional years subject to City Council approved budgets.

PDA16-002) BETWEEN THE CITY OF ONTARIO AND CVRC ONTARIO INVESTMENTS, LLC, FOR THE POTENTIAL DEVELOPMENT OF UP TO 480 RESIDENTIAL UNITS (FILE NO. 10. CONSTRUCTION CONTRACT FOR EXPANSION OF THE CNG FACILITY AT THE ONTARIO MUNICIPAL SERVICES CENTER (OMSC)

City Council approved the plans and specifications and awarded Contract No. MS 2015-16-1 to Fueling and Service Technologies, Inc. (FASTECH) of Buena Park, CA, for the construction of OMSC CNG Facility Expansion in the amount of \$131,136 plus a 15% contingency of \$19,670, for a total amount of \$150,806; and authorized the City Manager to execute said contract and file a notice of completion at the conclusion of all construction activities related to the project.

11. CONSTRUCTION CONTRACT FOR RECYCLED WATER MAIN IMPROVEMENTS IN RIVERSIDE DRIVE AND JURUPA STREET

City Council approved the plans and specifications and awarded Contract No. UT 1002 to Norstar Plumbing and Engineering, Inc. of Alta Loma, California, for the construction of the Recycled Water Improvements for Riverside Drive and Jurupa Street in the amount of \$3,312,219 plus a 15% contingency of \$496,833,

for a total amount of \$3,809,052; and authorized the City Manager to execute said contract and file a notice of completion at the conclusion of all construction activities related to the project.

**UNANIMOUSLY CARRIED:** Mayor Leon declared City Council Resolution Nos. 2018-030, 2018-031 and 2018-032 and Ordinance Nos. 3094 and 3095 unanimously adopted.

# 12. CONFIRMATION OF APPOINTMENT OF DEPUTY POLICE CHIEF DEREK WILLIAMS TO POLICE CHIEF.

City Manager Ochoa noted his recommendation that the City Council confirm Derek Williams as the next Police Chief, and requested ratification.

Council Member Dorst-Porada expressed her appreciation to Deputy Chief Williams for stepping in for Chief Kaylor, and commented that she believes he will make a great chief.

Mayor pro Tem Wapner noted the City's long legacy of great police chiefs and commented that Ontario has the best police department in the Country. He congratulated Deputy Chief Williams on this appointment.

Council Member Bowman indicated that he feels that Mr. Williams will do a wonderful job, noting his family's support of his efforts.

Council Member Valencia concurred that Deputy Chief Williams was the right person for the job. He welcomed him as the Chief.

Mayor Leon stressed the importance of getting the right person for the job, and having someone who will provide consistency, reliability and accountability.

**MOTION:** Moved by Mayor pro Tem Wapner, seconded by Council Member Bowman and carried by unanimous to confirm Derek Williams as Ontario's new Police Chief.

# CITY CLERK MAUTZ ISSUED THE OATH OF OFFICE TO POLICE CHIEF DEREK WILLIAMS.

Chief Williams commented that it was an honor and a blessing to be in this position. He reflected on his career which began after leaving the Air Force, 28 years ago; and he introduced and thanked his family for their support.
