#### **JOINT MEETINGS**

Regular meetings of the Ontario City Council/Ontario Housing Authority/Successor Agency to the Ontario Redevelopment Agency were held on Tuesday, August 20, 2019, at the Ontario City Hall, 303 East B Street, Ontario, California.

### CALL TO ORDER - OPEN SESSION

Mayor Leon called the City Council and Housing Authority meetings to order at 6:31 p.m.

Also present were City Manager/Executive Director Scott Ochoa, City Attorney/Legal Counsel Scott E. Huber, and City Clerk/Secretary Sheila Mautz.

The Pledge of Allegiance was led by Council Member Dorst-Porada.

The Invocation was provided by *Pastor Dan Lin*, representing Home of Christian-Bethel Church.

### PUBLIC COMMENTS

Edgar Romero, through an interpreter, complained about an issue he's having with the Code Enforcement Department. He thanked Assistant City Manager Boling and Assistant Planning Director Zeledon and the Police Department for their assistance so far in handling the issue of parking his truck in front of his house; however, he requested the Mayor's assistance and noted that the issue is affecting his health and he is considering selling his house. He said he feels like a victim and is now frustrated and desperate. Mayor Leon requested input from the City Manager. City Manager Ochoa suggested that Mr. Romero be referred to Assistant City Manager Boling and Deputy Police Chief Lorenz as the truck is still parked in violation of City codes and the City Council would not be the appropriate ones to address the matter.

Phillip Rodman, representing residents of the City Center Senior Apartments, questioned statements reportedly made by Mayor Leon at the dedication of the facility in 2010 Ontario City Council/Ontario Housing/

regarding affordability and requested that the Mayor meet with the residents regarding recent rent increases. City Manager Ochoa suggested that Executive Director of Housing Bjork meet with Mr. Rodman to address his issues, and he explained that the City's investment in the project keeps the rents at about half of the current market rate and within the guidelines for affordability.

Julie Teeter, expressed concerns with a proposed church to be located behind her home on Locust Street. She noted that their street is a quiet cul-de-sac and many children and grandchildren play and ride their bikes there. She expressed concern with their street being opened up as an entrance for the church.

Russell Sprague indicated that he lives on the southeast corner of Locust and Elderberry and expressed his concerns with the potential impact of the proposed church in his neighborhood. He explained that there are rumors that there is a rehabilitation facility associated with the church and shared his concern with the issues that such a facility might bring.

Zoila Bautista noted that she is a ten-year resident of Ontario and added her concern with regard to the proposed church. She suggested a padlocked gate to bar access to their neighborhood. She expressed concern with the additional traffic and noise this facility would present.

Sharon Palazzo indicated that the proposed church would be right behind her house. She expressed concern with access, the potential of a rehabilitation center, and the height of the church which potentially will block her view of the mountains.

Henry Deltann, agreed with the prior speakers and expressed concern with the possible rehabilitation facility and the increased traffic. He also noted concerns with the lights from the church impacting them at night.

City Manager Ochoa referred these residents to Development Director Murphy.

Karen Haughey, representing Supervisor Curt Hagman, congratulated the City on a very successful National Night Out event. She announced that the Supervisor's Office will be holding another document shredding event in honor of Crime Prevention Month, to bring awareness to identity theft prevention. The event will be held on Saturday, October 26, 2019 at Chino City Hall from 9:00 a.m. to noon. Shredding is limited to five boxes per vehicle and no cd's dvd's, binders or plastics are allowed.

### AGENDA REVIEW/ANNOUNCEMENTS

City Manager Ochoa announced that an update had been provided with regard to Item No. 13 to account for payments received up to 9:00 a.m. today. Total liens were reduced to \$156,672.31 on 41 parcels.

### **CONSENT CALENDAR**

Mayor Leon noted a request to speak on Item 29 from Lupe Camacho of the U.S. Census Bureau.

Lupe Camacho, U.S. Census Partnership Specialist for San Bernardino County, explained her background in the Inland Empire and noted the proposed resolution on the agenda for consideration. She stressed the U.S. Census Bureau's efforts to provide accurate information to the public about the census effort. She also noted that the census would be using a new, online format instead of mailers; and there has been more media coverage—which is good and bad. She stressed that the Census Bureau does not want anyone to be afraid of being counted.

Council Member Dorst-Porada inquired if Census Bureau staff had met with City staff. Ms. Camacho indicated that she had met with Assistant City Manager Boling. Ms. Camacho stressed the difficulties with the upcoming year's program and the public's fear of being counted.

Mayor pro Tem Valencia requested clarification on privacy issues and concerns. Ms. Camacho responded that Titles 13 and 26 require that no personal information may be provided to other federal agencies; and she stressed the high level of vetting being done to hire workers for this year's effort.

Ms. Camacho requested that the proposed resolution include language calling out specifically that the U.S. Census Bureau is a partner.

## 38. A RESOLUTION AUTHORIZING THE ISSUANCE OF SPECIAL TAX BONDS FOR COMMUNITY FACILITIES DISTRICT NO. 26 (PARK PLACE FACILITIES PHASE III)

City Council considered and adopted a resolution authorizing the issuance of special tax bonds for Community Facilities District No. 26 (Park Place Facilities Phase III).

### The resolution:

- (A) Authorizes the issuance of special tax bonds for public improvements required to facilitate the development of the Park Place Facilities Phase III project;
- (B) Approves the forms of the Indenture of Trust, the Bond Purchase Agreement, the Continuing Disclosure Agreement, and the Preliminary Official Statement;
- (C) Authorizes a negotiated sale of the special tax bonds to Stifel, Nicolaus & Company, Incorporated (the "Underwriter") in accordance with the terms of the Bond Purchase Agreement; and
- (D) Authorizes the execution of the Indenture of Trust, the Bond Purchase Agreement, the Continuing Disclosure Agreement, and the Preliminary Official Statement by the City Manager, or his designee.
