SUBJECT: A RESOLUTION RATIFYING THE PROCLAMATION OF A LOCAL EMERGENCY AND DIRECTING THE EMERGENCY ORGANIZATION OF THE CITY OF ONTARIO TO TAKE NECESSARY STEPS FOR THE PROTECTION OF LIFE, HEALTH, AND SAFETY IN THE CITY OF ONTARIO REGARDING A SANTA ANA WINDSTORM.

RECOMMENDATION: That the City Council ratify the Proclamation of Local Emergency and directing the emergency organization of the City of Ontario to take the necessary steps for the protection of life, health, and safety in the City of Ontario regarding a Santa Ana windstorm.

THE FOLLOWING COUNCIL GOAL(S) ARE BEING ACHIEVED: Maintain the Current High Level of Public Safety

FISCAL IMPACT: This resolution maintains the City's compliance with State and Federal requirements for emergency response. Furthermore, this action allows eligibility for State and Federal reimbursement if a state-wide disaster is declared for this windstorm event.

BACKGROUND & ANALYSIS:

Cities around the Southern California region were hit by a Santa Ana windstorm which caused significant damage, vegetation fires, and power outages. The City of Ontario had over 3,000 trees downed, hundreds of residents without power, downed powerlines, property damage and vegetation fires ignite within the city.

Through Ontario Ordinance No. 2990, the City Manager, as the Director of Emergency Services, can proclaim a local emergency in order to enhance the City's ability to mobilize local resources, coordinate interagency response, accelerate procurement of vital supplies, use mutual aid, and seek potential reimbursement by the State and Federal governments.

Per California Government Code § 8630, a proclamation of local emergency must be ratified by the governing body within 7 days of issuance and reviewed and continued every 30 days thereafter until termination of the local emergency as conditions warrant.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, PROCLAIMING THE EXISTENCE OF A LOCAL EMERGENCY AND DIRECTING THE EMERGENCY ORGANIZATION OF THE CITY OF ONTARIO TO TAKE THE NECESSARY STEPS FOR THE PROTECTION OF LIFE, HEALTH AND SAFETY IN THE CITY OF ONTARIO REGARDING A SANTA ANA WINDSTORM.

WHEREAS, City of Ontario Ordinance No. 2990 empowers the City Manager as the Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when said city is affected or likely affected by a public calamity and the City Council is not in session, and

WHEREAS, Government Code Section 8550 *et seq.*, including Section 8558(c), authorize the City Manager to proclaim a local emergency when the City is threatened by conditions of disaster or extreme peril to the safety of persons and property within the City that are likely to be beyond the control of the services, personnel, equipment, and facilities of the City; and

WHEREAS, on October 26, 2020, the City Manager, acting as the Director of Emergency Services, did proclaim the existence of a local emergency pursuant to City of Ontario Ordinance 2990; and

WHEREAS, the City of Ontario was impacted by a significant Santa Ana windstorm event that caused hundreds of calls for service for downed trees, powerlines, vegetation fires, public service requests, property damage, halted flights at Ontario International Airport for several hours; and

WHEREAS, several large vegetation fires in the Southern California region are drawing down fire resources in the area; and

WHEREAS, more significant Santa Ana wind events were still unfolding; and

WHEREAS, these conditions warrant and necessitate that the City of Ontario declare the existence of a local emergency.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Ontario, California, hereby proclaims the existence of a local emergency and directs the Emergency Organization of the City of Ontario to take the necessary steps for the protection of life, health and safety in the City of Ontario.

IT IS FURTHER ORDERED AND RESOLVED, that during the existence of said local emergency the powers, functions, and duties of the Emergency Organization of the City shall be those prescribed by state law, by ordinances, and resolutions of the City; and

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Proclamation of Local Emergency shall take effect immediately and that widespread publicity and notice shall be given said Declaration through the most feasible and adequate means of disseminating such notice throughout the City.

THE ONTARIO CITY COUNCIL FURTHER DIRECTS, that a copy of this Resolution be forwarded to the San Bernardino County Office of Emergency Services to be forwarded to the Director of the California Governor's Office of Emergency Services requesting that the Director find it acceptable in accordance with State law; that the Governor of California pursuant to the Emergency Services Act, issue a proclamation declaring an emergency in San Bernardino County; that the Governor waive regulations that may hinder response and recovery efforts; that response and recovery assistance be made available under the California Disaster Assistance Act; and that the State expedite access to State and Federal resources and any other appropriate federal disaster relief programs.

The City Clerk of the City of Ontario shall certify as to the adoption of this Resolution.

SUBJECT: FURTHER IMPLEMENTATION OF CALIFORNIA PUBLIC EMPLOYEE RETIREMENT SYSTEM (CALPERS) TWO-YEARS ADDITIONAL SERVICE CREDIT FOR DESIGNATED CLASSIFICATIONS, DEPARTMENTS OR ORGANIZATIONAL UNITS

RECOMMENDATION: That the City Council, by motion, adopt the resolution to ensure timely implementation of the two-years additional service credit in accordance with California Government Code section 20903 for designated classifications, departments or organizational units.

THE FOLLOWING COUNCIL GOAL(S) ARE BEING ACHIEVED: Operate in a Businesslike Manner

FISCAL IMPACT: Pursuant to the disclosures made during the City Council meeting on May 19, 2020, the present value of the program cost was estimated at \$28,309,000, or if amortized over five (5) years, \$6,376,000 per year based on 321 regular full-time employees that were determined to be eligible to participate and retire during the designated "window" period. The corresponding savings for the same eligible employees was estimated to be \$51,600,000 through future and ongoing personnel cost reductions to be attained through attrition and realignment of the workforce.

Consistent with the City's intent, and pursuant to the City Council's approval on June 2, 2020, the retirement election window closed on October 1, 2020. Of the 321 eligible employees, 181 elected to participate under the program. The total savings of salaries and benefits for those 181 employees is estimated at \$30,584,696 for a twelve-month period. The twelve-month savings to the general fund based on 130.15 employees is \$24,699,547 and for other funds based on 50.85 employees is \$5,885,149. The cost of the retirement separation for the 181 employees citywide is estimated at \$17,372,603 or if amortized over five (5) years, \$3,912,748 per year. General Fund's 130.15 FTE retirement cost is estimated at \$14,492,168, or \$3,286,524 per year if amortized over five years and the Other Funds of 50.85 FTE cost is estimated at \$2,780,435, \$626,224 per year if amortized over five years.

This action did or will result in freezing many of the vacated positions authorized in the FY 2020-21 adopted budget, and carry forward to the budgets for FY 2021-22 and future years.

BACKGROUND & ANALYSIS: California Government Code Section 20903 allows the City, as part of a budget reduction process, to offer a retirement incentive of two years additional service credit

to eligible employees that elect to retire during a designated window.

The City Council adopted Resolution No. 2020-066 to identify the positions eligible for the two years of additional service credit, and to designate the window period from June 3, 2020 through September 30, 2020. It was the understanding of staff, as communicated to all eligible employees and the City Council, that any eligible employee that terminated their employment with the City between June 4, 2020 (Section 20903 requires that an eligible employee be employed for at least one day within the designated window period) and September 30, 2020, with a retirement effective date no later than October 1, 2020, would receive two years of additional service credit pursuant to Section 20903. It was later determined, through communication with CalPERS, that the foregoing understanding did not conform to Section 20903 in that an eligible employee had to retire, not just separate from employment, between June 4, 2020 and September 30, 2020.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, RESCINDING RESOLUTION NO. 2020-066 AND APPROVING AN AMENDED AND RESTATED RESOLUTION AUTHORIZING A DESIGNATED PERIOD FOR TWO YEARS ADDITIONAL SERVICE CREDIT.

WHEREAS, the City of Ontario is a contracting Public Agency of the California Public Employees' Retirement System (CalPERS); and

WHEREAS, the City of Ontario desires to provide a designated period for Two Years Additional Service Credit, pursuant to California Government Code Section 20903 (Section 20903), based on the contract amendment included in City's contract with CalPERS which provided for Section 20903, Two Years Additional Service Credit, for eligible members as set forth below; and

WHEREAS, on June 2, 2020, the City Council adopted Resolution No. 2020-066 to identify the positions eligible for the two years of additional service credit, and to designate the window period from June 3, 2020 through September 30, 2020; and

WHEREAS, it was the understanding of staff, as communicated to all eligible employees and the City Council, that any eligible employee that terminated their employment with the City between June 4, 2020 (Section 20903 requires that an eligible employee be employed for at least one day within the designated window period) and September 30, 2020, with a retirement effective date no later than October 1, 2020, would receive two years of additional service credit pursuant to Section 20903; and

WHEREAS, it was later determined, through communication with CalPERS, that the foregoing understanding did not conform to Section 20903 in that an eligible employee had to *retire*, not just separate from employment, between June 4, 2020 and September 30, 2020; and

WHEREAS, in consultation with CalPERS and legal counsel, it was determined that in order to conform staff's understanding with the requirements of Section 20903 it is necessary that the City Council rescind Resolution No. 2020-066 and adopt this Resolution in its place to specify the intended designated window period from June 3, 2020 to October 1, 2020 pursuant to Section 20903.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ONTARIO DOES HEREBY RESOLVE AND DECLARE AS FOLLOWS:

<u>SECTION 1</u>. The City Council hereby rescinds, repeals, vacates and sets aside Resolution No. 2020-066 in its entirety.

<u>SECTION 2</u>. Pursuant to Government Code section 20903, the City Council hereby designates the period from June 3, 2020 through October 1, 2020, for eligible members in the following positions:
