JOINT MEETINGS

Regular meetings of the Ontario City Council/Ontario Housing Authority were held on Tuesday, March 19, 2019, at the Ontario City Hall, 303 East B Street, Ontario, California.

CALL TO ORDER

Mayor Leon called the City Council and Housing Authority meetings to order at 6:31 p.m.

The Pledge of Allegiance was led by Council Member Bowman.

The Invocation was provided by *Dr. Juan Williams Sr.*, representing Ontario Christian Center.

PUBLIC COMMENTS

William Torres expressed concern with an encounter he experienced with an Ontario police officer. City Manager Ochoa referred him to Deputy Police Chief Lorenz.

Heather Raymond spoke on behalf of the Promise Scholars Program, and thanked the City Council for their ongoing support of the program. She explained that through the partnership with the City, they are able to serve 14,000 students with efforts such as the Reindeer Run and City staff serving as role models during the business leader classroom presentations. She also noted that Promise Scholars works in partnership with community colleges to promote career preparedness after high school.

Laura Ramirez noted that she is a volunteer for Promise Scholars, a student at Chaffey College and a Police Explorer. She commented that Promise Scholars has opened doors for many students like herself and relieves the stress of paying for school for many parents. She encouraged other students to "never give up and always follow their dreams".

Raelyne Moreno distributed thank you gifts to the City Council and thanked them for their support of Promise Scholars. She explained her position as an Americorps working with students at Chaffey High School and described some of the programming.

Cherry Dobbs, Museum Associate, announced the upcoming Arts & Culture Awards event to be held at the Ontario Museum of History and Art on April 25, 2019 at 5:30 p.m. She explained that the event will be honoring artist Tony Sheets, cultural organization The Sam and Alfreda Maloof Foundation, and Patron of Arts and Culture Randall Lewis and the Lewis Family; with dinner and access to a new art exhibit.

City Council took the following actions:

- (A) Adopted a resolution authorizing the issuance of multifamily housing revenue bonds in an amount not to exceed \$23,000,000 for the purpose of financing the acquisition and construction of Vista Verde Apartments (the "Development"), approving and authorizing the execution and delivery of any and all documents necessary to issue the bonds and implement the resolution, and ratifying and approving any action heretofore taken in connection with the bonds; and
- (B) Adopted a resolution approving the Transformative Climate Communities Loan Agreement (the "TCC Loan Agreement") between the City of Ontario (the "City") and Virginia-Holt Housing, LP approving a loan in the amount of \$14,729,325 (the "TCC Loan").

MOTION: Moved by Council Member Dorst-Porada, seconded by Council Member Bowman and carried by unanimous vote of those present, with Council Member Wapner absent to adopt Resolution Nos. 2019-025 and 2019-026.

RESOLUTION NO. 2019-025 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, AUTHORIZING THE ISSUANCE, SALE AND DELIVERY OF MULTIFAMILY HOUSING REVENUE BONDS RELATED TO THE FINANCING OF VISTA VERDE APARTMENTS, AUTHORIZING THE EXECUTION AND DELIVERY OF RELATED DOCUMENTS, AND APPROVING ACTIONS IN CONNECTION THEREWITH.

City Council considered a resolution authorizing the issuance of special tax bonds for Community Facilities District No. 38 (Park & Turner NE Facilities). The resolution:

- (A) Authorized the issuance of special tax bonds for public improvements required to facilitate the development of the Park & Turner NE project;
- (B) Approved the forms of the Indenture of Trust, the Bond Purchase Agreement, the Continuing Disclosure Agreement, and the Preliminary Official Statement;
- (C) Authorized a negotiated sale of the special tax bonds to Stifel, Nicolaus & Company, Incorporated (the "Underwriter") in accordance with the terms of the Bond Purchase Agreement; and
- (D) Authorized the execution of the Indenture of Trust, the Bond Purchase Agreement, the Continuing Disclosure Agreement, and the Preliminary Official Statement by the City Manager, or his designee.

MOTION: Moved by Council Member Dorst-Porada, seconded by Mayor pro Tem Valencia and carried by unanimous vote of those present, with Council Member Wapner absent to adopt Resolution No. 2019-027.

RESOLUTION NO. 2019-027 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, AUTHORIZING THE ISSUANCE OF CITY OF ONTARIO COMMUNITY FACILITIES DISTRICT NO. 38 (PARK & TURNER NE FACILITIES) SPECIAL TAX BONDS, SERIES 2019, IN AN AGGREGATE PRINCIPAL AMOUNT OF NOT TO EXCEED \$12,000,000, AUTHORIZING THE EXECUTION AND DELIVERY OF AN INDENTURE, A BOND PURCHASE AGREEMENT AND A CONTINUING DISCLOSURE AGREEMENT, AUTHORIZING THE DISTRIBUTION OF AN OFFICIAL STATEMENT IN CONNECTION THEREWITH AND AUTHORIZING THE EXECUTION OF NECESSARY DOCUMENTS AND CERTIFICATES AND RELATED ACTIONS.

STAFF MATTERS

City Manager Ochoa noted the recent passing of Planning Commissioner Delman and recommended anyone wishing to serve as Commissioner to check the City Clerk's Office web page for an application.

COUNCIL MATTERS

Mayor pro Tem Valencia noted that he attended career day at Colony High School and was pleased to see Police, Fire and City staff participating. He also noted that he attended Western Little League Opening Day and it was a great day. He wished David Allen, who was present in the audience, a Happy Birthday.

Council Member Bowman commented on the upcoming State of the City event to be held on March 20, 2019 and encouraged everyone to attend.

Council Member Dorst-Porada asked that through the Promise Scholars program consideration be given to providing a list of possible vocations to 9th and 10th graders so they could plan for and obtain associated training through the program. She suggested that this would help student to more easily find direction in life. She also noted that she and Mayor Leon attended the Tot Olympics over the weekend and commented on the childrens' enjoyment as participants. She further noted the success of the collaborative program between the Ontario Fire Department and the American Red Cross that recently installed new smoke alarms in residences at the Lamplighter Mobile Home Park.

Mayor Leon commented on the use of social media and people's expectations for the City Council to monitor and respond to posts. He suggested the public use the "MyOntario" smartphone app to report things such as potholes to assure proper reporting and quick response.
