JOINT MEETINGS

Regular meetings of the Ontario City Council/Ontario Housing Authority were held on Tuesday, April 7, 2020, at the Ontario City Hall, 303 East B Street, Ontario, California.

CLOSED SESSION

Mayor Leon called the City Council/Housing Authority meetings to order at 6:01 p.m. and made the following announcement:

Mayor Leon called the City Council and Housing Authority meetings to order at 6:35 p.m.

REPORT ON CLOSED SESSION

City Attorney Huber advised that there were no reportable actions from the Closed Session discussions.

The Pledge of Allegiance was led by Council Member Bowman.

Mayor Leon led a moment of silent reflection in lieu of the Invocation.

TELEPHONIC PUBLIC COMMENTS

Omar Becerra, representing the U.S. Census Bureau, provided an update on the progress made with the 2020 Census. He indicated that field operations had been discontinued but the Census is continuing to reach out to as many people as possible through alternate means. He explained that the Census has a tracking website which shows that 44.4% of Ontario residents have completed the count.

Curt Hagman, San Bernardino County Supervisor, updated the City Council and public on the current COVID-19 statistics for the County including 547 reported cases, 17 deaths and 6,500 persons tested. He noted that the County had now issued a stay-at-home order; and if people have to leave their homes, they are required to wear a face covering. He also commented on the establishment of a Joint Incident Management Team and noted that additional information on COVID-19 was available on the County website.

AGENDA REVIEW/ANNOUNCEMENTS

City Manager Ochoa requested that Item No. 4 of this agenda be pulled to allow staff time to refine some of the language related to hotels and motels.

12. AN AMENDMENT TO THE CONSTRUCTION CONTRACT FOR ON-CALL REMEDIATION AND RESTORATION SERVICES/BELFOR USA GROUP, INC.

City Council approved and authorized the City Manager to execute Amendment No. 1 to the Construction Contract with Belfor USA Group, Inc., of Riverside, CA for on-call remediation and restoration services, adding \$365,000 for a revised not-to-exceed contract limit of \$375,000 over a term of three years.

MOTION UNANIMOUSLY CARRIED: Mayor Leon declared Resolution Nos. 2020-028 through 2020-035 (with the exception of No. 2020-029) and Ordinance No. 3158 adopted upon unanimous roll call vote.

PUBLIC HEARINGS

13. A PUBLIC HEARING TO CONSIDER AN URGENCY ORDINANCE RELATING TO THE EVICTION OF RESIDENTIAL TENANTS, COMMERCIAL TENANTS, AND STORAGE UNIT PATRONS EXPERIENCING LOSS OF INCOME DURING THE STATE OF LOCAL EMERGENCY CAUSED BY THE COVID-19 PANDEMIC

City Council read by title only, waived further reading, and adopted an urgency ordinance imposing regulations on the eviction of residential tenants, commercial tenants, and storage unit patrons experiencing a loss of income due to the COVID-19 pandemic.

Notice of public hearing was duly given and affidavits of compliance are on file in the Records Management Department.

There were no written communications.

Mayor Leon opened the public hearing asking those persons interested in this item to speak. Hearing no one, Mayor Leon closed the public hearing.

Council Member Wapner indicated that he could support the ordinance as presented but expressed concern that it was disjointed. He noted that if the renter does not pay rent, the property owner is still responsible for the mortgage payment. He stressed the need for property owner protections to assure that they are not foreclosed upon by the bank or mortgage holder. City Manager Ochoa indicated that he believes the State guidelines cover that aspect. Council Member Wapner requested that the City Manager investigate that further and, if necessary, bring back amendments to the City's ordinance.

Mayor Leon indicated that his understanding that under the State's guidelines it is covered as he feels that the State has been very thorough, but cautioned that affected people must apply for any rent waivers and the property owners must engage in dialogue with their banks as it goes up the chain. He noted that rents are not forgiven, they are just deferred. He also made clear that there is no clear discussion on whether or not interest is or can be applied to the deferred rents. He stated his belief that anything you pay rent for, including storage, would be covered. Mayor Leon stated that his real concern was that the State was giving only 90 days to cure the amounts in arrears, and that since we do not know how long the crisis will last it needs to be a longer time for repayment after the crisis is over.

Mayor pro Tem Dorst-Porada expressed her concerns for the people who cannot pay rent right now and the need for tenants to give their landlords notice that they are experiencing financial hardships due to COVID-19. She stated that a clarifying document should be developed by staff and brought back to City Council once State guidelines are better understood. She also indicated that she would like to see six months or longer as the repayment period.

Council Member Bowman commented that if people cannot make their rent payments now, then a short repayment period will not fix the problem.

Mayor Leon commented that there were several unanswered questions.

Council Member Valencia commented that people are stressed right now and cannot make rent payments. He suggested that the ordinance has enough details for now, and City Council can always adopt amendments later if needed. He noted that people are struggling, especially with their storage units that can be sold for non-payment, which particularly impacts the homeless community.

Mayor Leon reiterated that the State is already covering most of the topics discussed, and it is a matter of contacting their lenders to put them on notice that the tenants are applying for deferral.

City Attorney Huber confirmed that people must contact their landlords and the rent deferrals must be caused by a financial hardship related to the COVID-19 outbreak. He indicated that the Governor's order did not specify commercial or storage units. City Manager Ochoa agreed that there was a more blanketed statement about "rentals". He also noted that the City's proposed ordinance does specially address those types of rentals and allows for up to six months to cure.

Mayor Leon stressed the importance of making everything very clear for tenants to understand and follow.

Council Member Wapner expressed his concern with further financial hardships that would result if this matter is continued for two weeks until the next Council meeting. He inquired if the Governor's order or guidelines would provide sufficient protections in the meantime. City Attorney Huber indicated that the executive order was in place, but there were also some later guidance documents that referenced rentals. Council Member Wapner commented that the Governor's order for the State may not address a mortgage holder's non-payment to the bank due to loss of rental income and suggested that at some point, someone would lose out. City Attorney Huber indicated that this fine point was not addressed, but that the Governor had reportedly met with the four largest mortgage holders in the State and they all agreed to forebear the impacted mortgage payments. Council Member Wapner indicated he would like something like this implemented if not now, perhaps the ordinance could be expanded upon later.

Mayor pro Tem Dorst-Porada stated that she liked Council Member Valencia's suggestion of adopting the ordinance as is and amending it in the future if refinements are deemed necessary.

MOTION: Moved by Mayor pro Tem Dorst-Porada, seconded by Council Member Bowman and carried by unanimous roll call vote to waive further reading and adopt urgency Ordinance No. 3159.

14. A PUBLIC HEARING TO CONSIDER AN ORDINANCE APPROVING A DEVELOPMENT CODE AMENDMENT (FILE NO. PDCA20-001) TO AMEND ONTARIO DEVELOPMENT CODE SECTION 4.02.010.D.2.F, BILLBOARD RELOCATION AGREEMENTS, INTERAGENCY RELOCATION EXCEPTION, TO REVISE THE LOCATIONAL CRITERIA AND THE NUMBER OF BILLBOARDS TO BE ELIMINATED WITHIN THE CITY

City Council introduced an ordinance approving a Development Code Amendment (PDCA20-001) amending Ontario Development Code Section 4.02.010.D.2.f, Billboard Relocation Agreements, Interagency Relocation Exception, to revise the locational criteria and the number of billboards to be eliminated within the City.

Notice of public hearing was duly given and affidavits of compliance are on file in the Records Management Department.

There were no written communications.

Mayor Leon opened the public hearing asking those persons interested in this item to speak. Hearing no one, Mayor Leon continued this public hearing to April 21, 2020.

STAFF MATTERS

City Manager Ochoa provided and overview of the impact of COVID-19 on the City of Ontario. He praised the City Council for forcing the issue with the County of knowing the number of cases in each city, making it possible to know where the infection is and provide the ability to arrest its growth. He noted that staff is waiting for more testing to be completed in order to know the true conditions within our community. He reminded the community that City Hall is open by appointment only, after screening questions, and with personal protective equipment being worn. He stressed that all utility department and public safety employees are in full operation and that first responders are being tested as-needed based on possible exposure incidents. He indicated that the Emergency Operations Center was active on a 24/7 basis and costs incurred are being tracked regarding the COVID-19 event. He estimated that the City's costs would be about \$2 million, and the City will be seeking reimbursements from FEMA and CalOES.

City Manager Ochoa noted that the City is working to reduce stress on the community, so there would be no utility shut offs or fines for late utility bill payments. He also noted the earlier action on this agenda to defer rent evictions and allow a six-month grace period for payments. He advised that senior meals have been a high-profile service serving 2,521 free meals to the low-income population. He indicated that information distributed via the internet and social media has had over 71,000 views and the online appointment setting for City Hall departments is a function that will continue even after the crisis is over. Through social media the City is getting the word out and providing accurate information such as a non-essential business hotline for people to call about businesses that should not be operating, and the virtual Community Life and Culture Agency's

Resource Center has done a great job of providing video content for programming. There have been 74 essential businesses have received letters from the City concerning their continued operations. The business community has also stepped up to provide N-95 masks, face coverings, and gowns. Ochoa announced that Fire Chief Gayk now serves as the Branch One Director for the Countywide Incident Management Team, and information is being shared and monitored on infections locally. The Ontario Convention Center is under an MOU with the County to serve as a surge hospital location if needed. Ochoa stated that Mayor Leon has been recording weekly videos providing updates to the community, and the economic impacts on the City are being analyzed by staff. He noted that overall the community is resilient, crime and calls for service are down, and people all seem to want to lend a hand. Ochoa concluded his report stating that staff is all safe and very satisfied with contributing to the well-being of the community.

COUNCIL MATTERS

Council Member Valencia gave kudos to City staff, noting that many are doing jobs other than their own, stepping up and taking on new tasks. He expressed appreciation for their resiliency and pride in their efforts to retool where necessary. He noted a local business, Gold Crest Industries, that normally manufactures patio furniture and had now shifted to making masks and were exploring the opportunity to make much-needed gowns. He commended their efforts and noted there many similar stories of other businesses retooling to meet the demands of essential workers and first responders.

Council Member Bowman commended the team effort by everyone including the City Council, City Manager and staff. He indicated that everyone is doing a wonderful job and appreciates the significance of their effort. He expressed pride in the City of Ontario leadership.

Mayor pro Tem Dorst-Porada commented on the use of social media for information and difficulty in filtering what is accurate; and she suggested that the public adhere to calls for social distancing and compliance with health precautions as they change. She noted that she received an email within the last few hours from the County establishing the need to wear face coverings when going out in public, and she encouraged the public to comply. She expressed concern about the number of available ICU beds in the County and suggested the City Manager communicate to the County CAO about the need for regular updates on beds available. Mayor pro Tem Dorst-Porada noted that she and Council Member Bowman both celebrated birthdays over the weekend, and she announced the birth of her granddaughter on Sunday.

Council Member Wapner clarified for the public that the City Council sets policy direction for the organization and the City Manager is charged with providing day-to-day leadership to implement policy. He expressed his support of the City staff who knows exactly where they are going; and he said he is proud of them for taking care of the community. He thanked the City Manager and staff for their efforts.

Mayor Leon commented on the COVID-19 crisis and noted the worldwide reactions. He reminded the community to take the situation seriously and wear face coverings while out in public. He compared this crisis to the Spanish flu in history and indicated that a strong defense is isolation. He commended the good acts of local businesses and thanked them for their efforts. He reminded everyone that online shopping was an option to comply with social distancing guidelines. He thanked City Manager Ochoa for his thorough report on the City's response to COVID-19 and stressed the City's efforts to keep the public informed.
