City Attorney Brown reported that the case listed on the agenda was discussed, however there was no reportable action.

PUBLIC COMMENTS

Dale Robinson, expressed concern with airport noise, particularly in the night time hours. He questioned the operational hours for flights and requested answers. City Manager Ochoa indicated that staff would contact him tomorrow.

Rudy Favila, congratulated the Council on regaining control of the airport, but stressed the need to control the destiny of the airport. He too commented on concerns with airport noise.

Peggi Hazlett, encouraged everyone to vote in the Statewide General Election before the polls close at 8:00 p.m. this evening. She thanked the community and City Council for their support of the 58th Annual Police Recognition Luncheon, noting it was the largest one ever. She noted the success of the recent Pancakes and Politics discussion and noted that there would be further discussion of workforce housing availability. She announced the June 6, 2018 Good Morning Ontario event, with Therese Andrews as the speaker to detail the services provided by Traveler's Aide; and she noted the Chamber's interest in future presentations highlighting other community non-profits.

Jesus Fonseca, expressed concern with airplane noise over his home. He indicated that he files complaints all the time, but receives no response. Mayor Leon indicated that staff will contact him tomorrow.

City Council authorized the City Manager to enter into an Agreement for Purchase and Sale and Joint Escrow Instructions with SC Ontario Development Company LLC, a Delaware limited liability company, for the purchase of a Fire Station Site in Ontario Ranch and a License and Reimbursement Agreement to jointly construct related street and other utility improvements to serve the site and the adjoining property.

6. A RESOLUTION APPROVING AN APPLICATION FOR THE USED OIL PAYMENT PROGRAM CYCLE 9 (FISCAL YEAR 2018-19) FROM THE STATE OF CALIFORNIA DEPARTMENT OF RESOURCES RECYCLING AND RECOVERY

City Council adopted a resolution approving a grant application for an estimated \$48,000 from the Used Oil Payment Program Cycle 9 (Fiscal Year 2018-19) through the State of California Department of Resources Recycling and Recovery (CalRecycle); and authorized the City Manager or his designee to execute all necessary documents to participate in the program.

STAFF MATTERS

City Manager Ochoa had no comments.

COUNCIL MATTERS

Mayor Leon commented on the airport noise issues mentioned this evening and noted that with the anticipated success of the airport, he did not see the noise factors getting less or quieter. He noted that the FAA had reduced the noise contour for the Part 150 Program because airport activity level was lower, but should be some future consideration for Ontario residents with increased airport activity projected.

Mayor pro Tem Wapner commented on the economic benefits for the community that comes with additional flights, but expressed understanding for the related impacts to the community. He noted that many of the planes flying over Ontario are not from our airport, but their flight patterns are all under federal FAA control. He noted similar concerns that were raised in the Lake Arrowhead area, and encouraged the residents to attend the Ontario International Airport Authority meetings with their concerns.

Council Member Dorst-Porada thanked the Kiwanis and Rotary clubs for a successful Car Show and Pancake Breakfast over the weekend. She also noted the availability of free Southland Symphony Orchestra concerts at the Bethel Community Church; and Chaffey Community Art Museum exhibits recently installed at the airport. She thanked the groups involved for their efforts and noted that the Arts & Culture website includes a calendar to find out about upcoming events.

Council Member Bowman noted a news event today in which Frontier Airlines announced the addition of flights from Ontario to Orlando. He also noted in response to the earlier noise complaints that upgrades to aircraft have made them much quieter, but he will work on behalf of the residents. He reminded the community that the polls are open until

8:00 pm., and encouraged voting. He concurred that the community has a lot to offer and noted the summer Concerts in the Park on Wednesday evenings and Movies in the Park on Friday evenings; as well as events offered at Citizens Business Bank Arena. Council Member Valencia also thanked the service organizations for putting on the Car Show and Pancake Breakfast, noting that it was an amazing event. He stressed that the downtown businesses also benefitted, noting it as good to get momentum in the downtown area. Valencia commented on a weekend event at Jay Littleton Ball Field, noting that the historic grandstands are in disrepair and there was a complaint about a person collecting money to participate at the field. He also commended Police Chief Williams for participating with his team in the annual Special Olympics Torch Run.

Mayor Leon noted that the Wednesday night Concerts in the Park will feature local talent prior to the 7:00 p.m. concerts. He stressed that there is a lot to offer for family entertainment in the community.

ADJOURNMENT

Mayor Leon adjourned the meetings of the Joint Agencies at 6:59 p.m. and announced the next regular meetings to be held on Tuesday, June 19, 2018.
