## JOINT MEETINGS

Regular meetings of the Ontario City Council/Ontario Housing Authority were held on Tuesday, February 7, 2017 at the Ontario City Hall, 303 East B Street, Ontario, California.

### CLOSED SESSION

Mayor pro Tem Dorst-Porada called the City Council/Housing Authority meetings to order at 6:03 p.m., and inquired whether persons were present who wished to speak to the Closed Session item. Hearing no one, the City Council with all members present except Mayor Leon, recessed to Closed Session at 6:03 p.m. for discussion of the following:

## **CLOSED SESSION REPORT**

City Attorney Brown advised that the Council conferred regarding the conference with the legal counsel about the existing litigation and reported that there was no reportable action.

### PUBLIC COMMENTS

Charles Carreli, requested dismissal of the lawsuit from the City regarding his property located at 1303 East E Street and stated that the code enforcement violations have been corrected.

Marci Garcia, Library Trustee spoke about her service as a Board Member over the past four years. She expressed her interest to stay on the Board for another four years and added that she has submitted her application and is ready to serve.

Paul Mim Mack, commented on the current and previous appointment processes for Boards and Commissions and asked Council to revert the process back. He commented on the 2016 Election results, stating that Council Member Valencia was the number one vote getter. He stressed the importance of allowing each member of Council to make their own appointments to the Boards and Commissions as the chosen representatives of the voters.

Mia Padilla and Haley Langley, Girl Scouts Troop 51044, reminded the public about Girl Scouts cookie time. They detailed their activities as members of the Girl Scouts and invited the public to support their Troop on Saturday by purchasing Girl Scouts cookies at the Walmart in Chino.

## 1. APPROVAL OF MINUTES

### 2. BILLS/PAYROLL

Approved **Bills** for the period of December 11, 2016 through January 7, 2017, in the amount of \$10,115,697.27 and **Payroll** for the period of December 11, 2016 through January 7, 2017, in the amount of \$5,830,842.35, when audited by the Finance Committee.

3. AN ORDINANCE AMENDING CHAPTER 4 TO TITLE 2 OF THE ONTARIO MUNICIPAL CODE, RELATING TO THE CUSTODY AND USE OF THE OFFICIAL CITY SEAL AND CITY INSIGNIA

City Council adopted Ordinance No. 3066 which established permissible uses of the official City seal and City insignia. Introduction and first reading of said Ordinance took place at a regular meeting of the City Council on January 17, 2017.

ORDINANCE NO. 3066 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, AMENDING CHAPTER 4 TO TITLE 2 OF THE ONTARIO MUNICIPAL CODE, RELATING TO THE CUSTODY AND USE OF THE OFFICIAL CITY SEAL AND CITY INSIGNIA.

4. AUTHORIZE THE PURCHASE OF FIBER OPTIC CABLE/CONDUIT EQUIPMENT AND MATERIAL AS PART OF THE CONSTRUCTION OF THE CITY'S HIGH-SPEED INTERNET (BROADBAND) NETWORK

City Council took the following actions:

- (A) Awarded Bid #698 for the purchase and delivery of fiber optics cable material and equipment in the amount of \$502,197 plus applicable taxes and shipping, from Graybar Electric of San Bernardino, California; and
- (B) Awarded Bid #699 for the purchase and delivery of fiber optics conduit material and equipment in the amount of \$372,274 plus applicable taxes and shipping, from Performance Utility Supply of Corona, California, for the City's High-Speed Internet (Broadband) Network project.
- 5. ORDINANCE LEVYING SPECIAL TAXES WITHIN CITY OF ONTARIO COMMUNITY FACILITIES DISTRICT NO. 25 (PARK PLACE FACILITIES PHASE II)

City Council adopted an ordinance levying special taxes within City of Ontario Community Facilities District No. 25 (Park Place Facilities Phase II). Introduction and first reading of said Ordinance took place at a regular meeting of the City Council on January 17, 2017.

**ORDINANCE NO. 3067** AN ORDINANCE OF THE CITY OF ONTARIO, CALIFORNIA, LEVYING SPECIAL TAXES WITHIN THE CITY OF ONTARIO COMMUNITY FACILITIES DISTRICT NO. 25 (PARK PLACE FACILITIES PHASE II).

**MOTION UNANIMOUSLY CARRIED.** Mayor Leon declared Ordinance No. 3066 and 3067 unanimously adopted.
