ASSOCIATE PLANNER

DEFINITION

This is journey-level professional work in the field of urban planning. Under Direction, performs as part of a team responsible for either long-range or current planning. Participation in a broad range of urban planning programs is expected. May provide functional supervision over professional, technical and clerical personnel. Work is reviewed through conference and analysis of reports.

EXAMPLES OF IMPORTANT AND ESSENTIAL DUTIES

Advanced Planning Section: Conducts independent investigations and performs technical analysis and administration of long-range projects, including general plan amendments, specific plans, environmental impact reports, spheres of influence/annexations, ordinance preparation/revisions, and airport land use reports; assists in the formulation of planning policy; provides information on planning regulations and issues to the public; supervises the work of consultants and subordinates assigned to long-range planning projects.

<u>Current Planning Section:</u> Prepares recommendations and staff reports on zoning matters, including variances, conditional use permits, zone changes; meets and confers with government officials and the public on planning matters.

OTHER JOB RELATED DUTIES

Performs other job related duties and responsibilities as required.

JOB RELATED AND ESSENTIAL QUALIFICATIONS

MINIMUM:

Graduation from a four year college with a bachelor's degree in urban planning or closely related field; two (2) years of recent experience in long-range or current planning, preferably with a public agency; a master's degree in urban planning or a closely related field may be substituted for one (1) year of required experience.
