- 4. Approval of Minutes
 - Minutes of June 9, 2020 were approved on a motion by Rick Caughman and seconded by Randy del Turco.
- 5. Public Comment None
- 6. City Council Liaison Thanked staff for putting together the budget.
- 7. Staff Report Director's Report
 - J. Worden reported on the planned opening of the Museum July 2. He presented a draft of the Strategic Plan that is scheduled for adoption at the next board meeting on June 30, 2020. The current Strategic Plan has been the key to our success, and we have accomplished much by actively using it. The Director provided a brief overview of the plan; the current plan covers fiscal year 16/17 to fiscal year 20/21. The three areas of focus are Enhancing the Physical Environment, Engaging Diverse Communities, and Presenting a Dynamic Experience. The COVID-19 pandemic and budget cuts have led to the Museum to be more creative and think outside the box. For the updated Strategic Plan, two new areas of focus have been added: Achieve Accreditation and Develop Additional Resources.
 - Board Comments: Appreciate how Accreditation was pulled out and made a focus
 area. This is a living document and any information gathered from workshops and
 additional feedback can be added after adoption.

- 8. Old Business Update on Strategic Planning Website Presentation by Board Member Caughman
 - R. Caughman presented a sample of a landing page he created for the Museum.
 - The Board and Staff have all realized the necessity to provide access to the
 community that does not require the public to physically visit the Museum. It is
 important to consider the virtual aspect in a Post-COVID time, both for people
 unable to visit the museum, and to enrich the experience of people who do visit the
 museum.
 - R. Caughman recommended that the Museum take the exhibits (current and future) and create a landing page that is exhibit centric, it promotes the exhibit. This page would have its own URL and the City would host it.
 - The idea is to provide a virtual window into the Museum focusing on exhibits. It is doable, inexpensive and can be done now. This page can be used as a marketing tool.
 - Board Comments: The Board likes the concept and the user friendliness of the page. It takes the Museum to the next level. Would like to see schools and teachers use the website as a learning resource.
 - City Manager's Comments: The City Manager fostered discussion about the concept from different perspectives and recommended further exploration of the concept.
 - The Director will arrange for further presentation and discussion of the concept with appropriate City staff, including the Director of CLC and the Communications team.
