


GENERAL REQUIREMENTS

- 2 drawing approved by the Landlord and obtain a valid sign permit from the Building Department. Prior to manufacturing, the tenant shall submit to the City of Ontario Planning Department at least three copies of the sign
- ω 4 τ The tenant shall pay for all of their signs, installation, (including final connection), permit labor and permit fees
- The tenant shall be responsible for fulfillment of all the requirements of this sign criteria
- sign contractor(s). Sign contractor will repair any damage caused by his work, and tenant shall be fully responsible for the operations of his
- 6 The Landlord shall furnish an electrical circuit for each sign. The Landlord shall have control over the hours of illumination of all building signs.
- 7 Upon termination of the lease, the tenant shall be responsible for removing their sign, patching any holes in the fascia, and monument sign, the tenant will replace their sign panel(s) with a blank panel(s) to match the color and texture painting them to match the surrounding wall color in a manner acceptable to the Landlord. If the tenant has space on a
- Ω Promotional or special event signs, banners and flags shall be in conformance with the City of Ontario Sign Ordinance and must have prior written approval from the Landlord prior to submission to the City.
- 9 No other types of signs except those specifically mentioned within this criteria will be allowed without prior written approval from the Landlord and the City.
- 11. Any sign on which stains or rust appear, or which becomes damaged in any way, or which in any manner whatsoever 10. It is understood that there may be the need for additional signs for information and directional purposes. These signs will be reviewed by the Landlord and the City Planning Department for consistency of design with the Center prior to installation.
- any signs not maintained properly or not in accordance with this sign program. is not maintained properly, shall be promptly repaired by tenant. Landlord may remove and store, at tenants expense



SIGN DESIGN GUIDELINES FOR ALL SIGNS

- Signs shall be designed in a manner compatible with the shape and layout of the architectural features of the building. Signs shall be consistent with the scale and proportions of the building elements within the facade.
- Incorporating logos and/or images to enhance the signage identity is encouraged. Designs and colors to be approved by the Landlord and the City of Ontario.
- Wall signs shall not have any visible attachments unless the attachments make an intentional statement or are architectural elements.
- All exterior (exposed) sign surfaces shall be primed and painted or pre-coated.
- 5. Wall signs shall consist of individual, interior-illuminated, plastic faced metal channel letters or reverse channel letters with indirect and direct lighting. Can signs as logos may be allowed on a case by case basis by the Landlord and City of Ontario, providing it is a registered trademark or symbol commonly used by the applicant.
- Wall sign placement must be centered both veritically and horizontally within the sign fascia area. Wall signs are not to exceed 75 percent of fascia/building width.
- Sign square footage shall be calculated by drawing up to (8) straight lines around copy and logo.

OTHER SIGNAGE

FREE STANDING SIGNS:

A total of three (3) monument signs will be allowed. Monument signs will be located at each entrance to the center as shown on site plan.

DIRECTIONAL SIGNS:

Directional signs are allowed with a maximum of ten (10) square feet of area and four (4) feet of overall height. Such directional signs shall only contain information necessary for on-site circulation, parking, and information. No advertising is allowed. Tenant identity will be allowed. All directional signs must be approved by the Landlord prior to submission to the City of Ontario.

MENU BOARD SIGNS:

Menu boards located on the interior driveways of drive-through facilities shall not exceed forty eight (48) square feet in area and six (6) feet in overall height. Speakers shall face away from residential property. No more than three (3) menu boards per drive-through shall be permitted.

MESSAGE SIGNS:

Electronic message signs or time/temperature signs will be allowed. Approval will be on a case by case basis by the Landlord and the City of Ontario and must be in writing.

PROHIBITED SIGNS:

Roof or ground inflated balloons/figures or bench signs except as authorized and approved by the City of Ontario and Landlord. A-frame signs.

Signs affixed to a vehicle, excluding permanent signs on commercial vehicles.

Signs deemed to be immoral, obscene, or unlawful.

Billboards.

Flashing, blinking, rotating or otherwise animated signs. Signs that emit or generate sound, smoke or similar material. Awning signs.



ON THE EAST, WEST, AND SOUTH ELEVATIONS AS SHOWN ON THE SITE PLAN. WILL BE ALLOWED. MAXIMUM SIZE OF SIGNAGE PER ELEVATION NOT TO EXCEED ONE HUNDRED (100) SQ. FEET PER SIGN. SIGNS ARE LOCATED MAJOR TENANT WILL BE ALLOWED THREE (3) WALL SIGNS. INDIVIDUAL ILLUMINATED CHANNEL LETTERS AND ILLUMINATED CAN TYPE LOGOS

DETERMINE THE VALIDITY OF THE REQUEST. SIGN LOCATION ON THE BUILDING, THE LANDLORD AND THE CITY OF ONTARIO SHALL REVIEW THE APPLICATION AND HAVE THE RIGHT TO WILL BE ONE (1) SQUARE FOOT OF SIGN AREA PER LINEAR FOOT OF BUILDING FRONTAGE. IN THE EVENT THAT A TENANT DESIRES A DIFFERENT SQUARE FOOT OF SIGN AREA PER LINEAR FOOT OF BUILDING FRONTAGE. TOTAL AREA OF SIGNS LOCATED ON THE EAST AND WEST ELEVATIONS EXCEED 36", INCLUDING SPACE BETWEEN LINES. TOTAL AREA OF SIGNS LOCATED ON THE EAST ELEVATION WILL BE ONE AND ONE-HALF (1 1/2) OFFICE BUILDING WILL BE ALLOWED SIX (6) TENANT SIGNS. TENANT SIGNS ARE ALLOWED UP TO 24" LETTER HEIGHT. 
RETAIL BUILDING WILL BE ALLOWED EIGHT (8) TENANT SIGNS TO BE LOCATED AS FOLLOWS:


ELEVATIONS WILL BE ALLOWED ONE (1) SQUARE FOOT OF SIGN AREA PER LINEAR FOOT OF BUILDING FRONTAGE. ONE AND ONE HALF (1 1/2) SQUARE FOOT OF SIGN AREA PER LINEAR FOOT OF TENANT LEASED SPACE. SIGNS LOCATED ON EAST AND WEST LINES NOT TO EXCEED 30", INCLUDING SPACE BETWEEN LINES. TOTAL AREA OF SIGNS LOCATED ON THE NORTH AND SOUTH ELEVATIONS WILL BE DISCRETION IN GRANTING SIGN RIGHTS ON THE SIDE ELEVATIONS. RETAIL TENANT SIGNS ARE ALLOWED UP TO A 24" LETTER HEIGHT. TWO THREE (3) ON NORTH ELEVATION, TWO (2) EACH ON SOUTH & EAST ELEVATIONS, AND ONE (1) ON WEST ELEVATION. THE LANDLORD HAS SOLE


STARBUCKS/QUIZNOS BUILDING: EACH TENANT WILL BE ALLOWED ONE (1) WALL SIGN PER ELEVATION. ILLUMINATED CHANNEL LETTERS AND ILLUMINATED CAN TYPE LOGOS WILL BE ALLOWED. EACH TENANT WILL BE ALLOWED SEVENTY-FIVE (75) SQ. FEET PER SIGN.

APPROVAL OF COLORS BY LANDLORD SHALL BE OBTAINED PRIOR TO SUBMITTING TO CITY OF ONTARIO. COLOR OF FACES, TRIM CAP AND LETTER RETURNS SHALL BE BY TENANT'S CHOICE. EXCESSIVE COLORS WILL NOT BE ALLOWED, WRITTEN


CONSTRUCTION REQUIREMENTS FOR ALL SIGNS

- Sign contractors must be U.L. Approved, fully licensed with the city and state, with full Workman's Compensation and general liability insurance.
- Signs must be constructed of durable, rust-inhibited materials that complement the design intent of the tenants identity and are complementary to the architecture.
- 3. No exposed conduit, transformers, or wiring will be permitted on the fascia. Exposed raceways are not allowed unless they are incorporated into the overall design of the sign. All penetrations of the building required for sign installation shall be neatly sealed in a watertight condition. Color and finish to match existing wall.
- No sign manufacturer labels shall be permitted on the surfaces of the letters that are visible from the ground.
- All signs shall bear the Underwriters Laboratories label, and shall comply with local building and electrical codes.
- It is the responsibility of the tenants sign company to obtain a sign permit from the City of Ontario and verify the location of each sign and the type of wiring method required.
- All sign fabrication and lighting must match the specifications of the approved working drawings. Internal illumination to be 30 milliamp neon or L.E.D. modules. Sloan or Gelcore are the approved L.E.D. systems to be used.
