Regular meetings of the Ontario City Council, Ontario Housing Authority and Ontario Redevelopment Agency were held on Tuesday, July 19, 2011, at the Ontario City Hall, 303 East "B" Street, Ontario, California.

CALL TO ORDER

The Mayor called the City Council Authority/Redevelopment Agency meetings to order at 6:05 p.m. asking if there was anyone present wishing to address the matter for Closed Session discussion. Hearing no one the Council adjourned to Closed Session at 6:05 p.m. with Council Members Mautz and Wapner, Mayor Pro Tem Dorst-Porada and Mayor Leon in attendance and Council Member Bowman absent.

The Mayor reconvened the City Council/Housing Authority/Redevelopment Agency meetings in open session at 6:30 p.m., and requested the City Clerk to call the roll.

The Invocation was offered by Reverend Nelson Grande, Westminster Presbyterian Church.

REPORT ON CLOSED SESSION

City Attorney John Brown reported that direction was given to Legal Counsel, however there was no reportable action.

PUBLIC COMMENT

Dorene Hopkins commented on the Walmart project, the lack of residents walking in the downtown area, the need for new curbing, a light pole, stop sign and speed limit signs on J Street in the vicinity of Sultana Avenue.

Wendy Myring requested that the City Council review the current agreement with the Humane society and detailed her recent interactions with them. She expressed particular concern with billings for 2010, during which time she was not in possession of the dogs but was being asked to show proof that she did not have them. Mayor Leon expressed understanding of her concerns and indicated that staff would do what they could to rectify the situation. Mayor Pro Tem Dorst-Porada indicated that she was very sympathetic to Ms. Myring's concerns and noted that she had less than nice interaction with the Humane Society in the past. Ms. Myring was referred to Deputy City Manager Boling for assistance.

Gene Rivera indicated that he had been a resident of Ontario for 35 years and worked in the community for over 25 years and was present to inform the Council of an issue with a company in the City, being BMW of North America. He indicated that he represents the Teamsters in that organization who were informed that on August 31st they would be replaced by an outsourcing company. He expressed concern that these would become low paying, non-benefited positions and create a bigger economic downturn for the community. He clarified that this discussion was not against the auto dealer Savage BMW, but instead the BMW corporation. He stressed that the persons being terminated were 20 and 30 year employees. He presented a packet of materials including a Los Angeles Times article and letters of support from Congressman Baca and Senator Boxer.

Tom Kitchens indicated that he had been working for BMW for the last 32 years starting in Carson and relocating to Ontario. He detailed the long term employment of the persons being terminated and stressed the impact on their families and their children.

Mark Reyes indicated that he has worked for BMW for over 24 years and expressed concern that the company had no interest in negotiating with the workers. He stressed that there had never been a work stoppage or strike in the history of the Ontario location and they have always negotiated in good faith. He expressed hopes that the Council would be in contact with BMW because 68 jobs were being lost in Ontario.

Mayor Leon commented that this was an unfortunate situation as they all sounded like loyal and committed associates of BMW. He indicated that he did not think this helped the current economic situation and suggested that in his opinion this was poor

management. He thanked the BMW employees for bringing this matter to the Council to explain the issue.

The City Council designated Mayor pro Tem Dorst-Porada as the City's voting delegate and Council Member Wapner as an alternate for the League of California Cities Annual Business Meeting scheduled for September 23, 2011.

4. STUDENT REPRESENTATIVE AND ALTERNATE APPOINTMENTS TO THE RECREATION AND PARKS COMMISSION FOR 2011/12 AND RECOGNITION OF THE CURRENT STUDENT REPRESENTATIVE FOR THE YEAR SERVED 2010/2011

The City Council confirmed Ana Villanueva as the Student Representative and Cody Thach as the alternate to the Recreation and Parks Commission for terms to expire June 30, 2012; and recognized Christopher Le Marr for serving as the Student Representative for the past year.

5. TEST CLAIM FILING FOR UNFUNDED MANDATES UNDER THE NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM STORMWATER PERMIT (MS4 PERMIT)

The City Council authorized joint participation with the San Bernardino County Flood Control District and other Co-Permittee cities in the Test Claim filing; contracted the law firm of Burhenn & Gest, LLP, of Los Angeles, California, to prepare and file the Test Claim with the Commission on State Mandates concerning unfunded mandates in the MS4 Permit, Regional Water Quality Control Board Order No. R8-2010-0036; and authorized the City Manager to execute all related Test Claim documents.

6. RESOLUTION APPROVING AN IMPROVEMENT AGREEMENT, IMPROVEMENT SECURITY AND FINAL TRACT MAP NOS. 18789 AND 18791

The City Council adopted a resolution approving an Improvement Agreement, Improvement Security and Final Tract Map Nos. 18789 and 18791 located east of Edenglen Avenue and south of Riverside Drive, within the Edenglen Specific Plan area.

RESOLUTION NO. 2011-045 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, APPROVING AN IMPROVEMENT AGREEMENT, IMPROVEMENT SECURITY AND FINAL TRACT MAP NOS. 18789 AND 18791 LOCATED EAST OF EDENGLEN AVENUE AND SOUTH OF RIVERSIDE DRIVE, WITHIN THE EDENGLEN SPECIFIC PLAN AREA.

7. AMENDMENT TO THE PURCHASING AGREEMENT WITH BOUND TREE MEDICAL, LLC FOR THE PURCHASE OF PARAMEDIC SUPPLIES/BOUND TREE MEDICAL, LLC

The City Council authorized the extension of the purchase agreement (Bid No. 09.07-01) awarded to Bound Tree Medical, LLC, of Visalia, California, for the purchase of paramedic supplies utilized by Fire Department EMS response personnel at an estimated annual cost of \$40,000.

8. AWARD BID FOR THE PURCHASE OF A HAZMAT RESPONSE VEHICLE/KOVATCH MOBILE EQUIPMENT CORPORATION (KME)

The City Council awarded Bid No. 103 to Kovatch Mobile Equipment Corporation (KME), of Ontario, California, in the amount of \$831,551 for the purchase and delivery of a new HazMat Response Vehicle.

COUNCIL/STAFF COMMENT

Council Member Mautz commented on the *American Idol* show at the Arena, noting that it was wonderful. She encouraged the public to take advantage of the programs presented at the Arena. She gave kudos to the Police Explorer Scouts who recently did a car wash as a fund-raiser and requested more advance notice for their next effort.

Council Member Wapner had no comments.

Mayor pro Tem Dorst-Porada commented on the Art Walk at the art lofts on Emporia, noting that it was a wonderful event which gets better every time. She noted that there will be another such event the third Saturday in September and encouraged participation. She indicated that *Sade* was coming to the arena. She announced the opening of the Ontario Rotary Police Museum and car show on Saturday, July 23, 2011. She also announced that preparations are underway for the annual Christmas on Euclid event. She commented that school would be starting soon and reminded the public of the need for the Pertussis Vaccine.

Mayor pro Tem Dorst-Porada noted that the Kids Come First Community Clinic had applied for and received a \$500,000 grant to rebuild.

Mayor Leon commented on events at the Arena and noted that it is an amazing venue with all good seats and a terrific sound system. He also commented on the "my Ontario" application for smart phones and encouraged residents to take pictures of problem areas and submit them for correction.

City Manager Hughes deferred his time to City Attorney John Brown. Mr. Brown introduced two law students serving as summer associates to the Ontario office of his law firm.
